ORDINANCE NO. 1, S. 1997

" AN ORDINANCE PROVIDING NEW RATE OF FEES FOR TRI-SIKAD AND IMPOSING PENALTIES FOR ANY VIOLATIONS THEREOF."

Be it ordained by the Sangguniang Bayan of Dumingag, Zamboanga del Sur, in session assembled that:

SECTION 1 - TITLE - This ordinance shall be called "DUMINGAG TRI-SIKAD INCENTIVE ORDINANCE."

SECTION 2 - PURPOSE - Pursuant to paragraph 2, Section 100 of the Implementing Rules and Regulations of the Local Government Code, the Sangguniang Bayan has the power to enact ordinance which shall provide tax incentives to the people. Therefore, this ordinance aims to ease the tri-sikad operator sector by providing incentives through a "NEW LOW ADJUSTMENT RATE OF FEES" for their operation.

SECTION 3 - NEW LOW ADJUSTMENT RATE - Fees and other charges are as follows:

A. REGULATORY FEES -	P120.00
* Mayor's permit	6 6 6 6 6 - - P 40.00
* Tax Clearance	- - - - - P 20.00
* Police Clearance	- - - - - P 10.00
* Mayor's Clearance	- - - - - P 10.00
* Registration Fee	- - - - - 20.00
B. TAX ON BUSINESS	P150.00
C. TOTAL	P270.00

SECTION 4 - OTHER REGULATORY MEASURE - The regulatory fees shall be collected only per unit.

SECTION 5 - PENAL PROVISIONS - Any person/operator/owner found guilty of violating these ordinances shall be penalized by a fine of not less than P500.00 but not more than P800.00 or an imprisonment of not less than two days, but not more than one week, or both at the discretion of the court.

SECTION 6 - ADMINISTRATIVE PROVISION - The Municipal Treasurer shall be the implementor of this ordinance.

SECTION 7 - SEPARABILITY CLAUSE - Any part or provision of this ordinance which shall be held unconstitutional or invalid, other parts of this not affected thereby shall continue in full force and effect.

SECTION 8 - REPEALING CLAUSE - Any resolution or ordinance inconsistent hereof is hereby modified, repealed or superseded accordingly.

Section 9 - EFFECTIVITY - This ordinance shall take effect immediately upon approval.
