Ordinance No. 1, s. 2006

AN AMENDATORY OF MUNICIPAL ORDINANCE NO. 5, S. 1998 FIXING THE NEW FARE RATES OF TRI-SIKAD OF DUMINGAG, ZAMBOANGA DEL SUR.

WHEREAS, in the enactment of the ordinance of the rate of trisikad, significant changes in the income and values of commodities and services have taken place;

WHEREAS, considering these changes, the present fare rate is no longer practical, viable and economically sound to both passengers and operators;

WHEREAS, by the power vested upon, the Sangguniang Bayan as the legislative body of the municipality shall enact proper ordinance for fare increase or adjustment basing upon the current fare, thereby fixing the same is indispensable;

NOW, THEREFORE, be it ordained by the Sangguniang Bayan in session assembled, that:

Section 1. TITLE. This Ordinance shall be called as "AN AMENDATORY ORDINANCE OF DUMINGAG TRISIKAD FARE RATES CODE OF 1998".

Section 2. SCOPE OF APPLICATION. This Ordinance shall apply to all tri-sikad for hire operating within the Municipality of Dumingag, Province of Zamboanga del Sur.

Section 3. DEFINITION OF TERM. As used in this ordinance, the word "Poblacion" shall cover the municipal streets.

Section 4. FIXED FARE RATES. There is hereby fixed fare rates per passenger of trisikad, to wit:

(a) Minimum fare rate - Three Pesos (P3.00) for trip within Poblacion

(b) The fare rates of the routes specified herein are as follows:

Route	Regular Rate
1. Poblacion - Guitran Bridge	P4.00
2. Poblacion - Caridad	7.00
3. Poblacion - Guitran	10.00
4. Poblacion - Upper Landing	10.00
5. Poblacion - Lower Landing	10.00
6. Poblacion - Maralag	10.00
7. Poblacion - Tumoy	10.00
8. Poblacion - Lunas	10.00
9. Poblacion - Dam	10.00
10. Poblacion - New Basak	10.00
11. Poblacion - Maliyo	10.00
12. Poblacion - Upper Timonan	15.00
13. Poblacion - Lower Timonan	15.00

(c) Route not specified will have a minimum fare of three pesos (P3.00).

(d) Preschoolers and elementary students are entitled to a special fare-less One Peso (P1.00) from the normal/regular rate.

Section 5. MANDATORY PROVISION. All trisikad operators/drivers are required to post/place the approved tariff in the vehicle visible to the passengers.

Section 6. ENFORCEMENT AGENCY. The Philippine National Police through its Municipal Police Station shall enforce this Ordinance at all times. All Punong Barangays concerned are enjoined to enforce this Ordinance in their respective areas of responsibility.

Section 7. PENAL PROVISION. Any Person who will violate the Provision of this Ordinance shall be dealt with accordingly:

- (a) First Offense. A fixed fine of FIFTY PESOS (P50.00) or imprisonment of two (2) hours or both at the discretion of the court
- (b) Second Offense. A fixed fine of ONE HUNDRED PESOS (P100.00) or imprisonment of four (4) hours or both at the discretion of the court
- (c) Third Offense. A fixed fine of ONE HUNDRED FIFTY PESOS (P150.00) and revocation of license for the driver at the discretion of the court

Section 8. GENERAL PROVISION. There shall be no limited route for the operation of trisikad within the municipality. Holder of revoked driver's license may be issued again with driver's license after two (2) years from the date of revocation upon recommendation of the traffic officer.

Section 9. SEPARABILITY CLAUSE. If any part or provision of this Ordinance may be declared invalid or unconstitutional, the remaining portions not affected thereby shall remain in full force and effect.

Section 10. REPEALING CLAUSE. Any previous resolution or ordinance inconsistent hereof is hereby modified, repealed or superseded accordingly.

SECTION 11. EFFECTIVITY CLAUSE. This Ordinance shall take effect on April 1, 2006 and after the approval of the Sangguniang Panlalawigan and after copies hereof is posted in the Bulletin Board at the entrance of the Municipal Hall and at least two (2) conspicuous places in the Poblacion and its publication of newspaper of general circulation in the province.

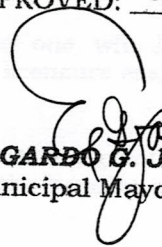
