Ordinance No. 1, s. 2013

AN ORDINANCE AMENDING LOCAL LAWS AND SUSPENDING THE IMPLEMENTATION OF SECTION 6 OF REPUBLIC ACT NO. 9211 ENTITLED, "AN ACT REGULATING THE PACKAGING, USE, SALE DISTRIBUTION AND ADVERTISEMENTS OF TOBACCO PRODUCTS AND FOR OTHER PURPOSES" IN THE MUNICIPALITY OF DUMINGAG, ZAMBOANGA DEL SUR.

Be it ordained by the Sangguniang Bayan of Dumingag, Zamboanga del Sur, in session assembled, that:

Section 1. **TITLE.**

This ordinance shall be called the "NO DESIGNATED SMOKING AREA POLICY OF DUMINGAG, ZAMBOANGA DEL SUR."

Section 2. **POLICY.**

It is hereby a declared policy of the LGU of Dumingag to protect the populace from the harmful effects brought about by the hazardous tobacco products, promote the right to health and instill health consciousness among its people.

Section 3. **PURPOSE.**

The purpose of the enactment of this ordinance is to promote a healthful environment through non-designation of smoking areas within the territorial jurisdiction of the municipality of Dumingag with due respect to the national law. This is not necessarily a defiance to the provision of the national law but merely an assertion of what the people has been accustomed to.

Section 4. **OPERATIVE PRINCIPLES.**

The municipality holds to do away the authorized designation of smoking areas as provided in Section 6 of RA 9211. Thus, it is hereby declared that the entire municipality of Dumingag, Zamboanga del Sur shall have NO DESIGNATED SMOKING AREAS including the barangays for the following justifications:

- the no-smoking policy was enacted in 1986, its implementation fares well and reaped good result
- the people had gradually internalized the noble intention and benefits of the no-smoking policy.....through the years, the no-smoking is not just a policy then but it became a way of life
- the municipality received various recognitions for its anti-smoking laudable initiatives and programs

it is believed that designation of smoking areas will definitely defeat and undermine the continuous, consistent and determined actions towards a "smoke-free municipality"

Section 5. SEPARABILITY CLAUSE.

Any provision of this ordinance or part thereof declared unconstitutional or unlawful, the other parts not affected shall remain in full force and effect.

Section 6. REPEALING CLAUSE.

Any part or provisions of existing ordinances and issuances in conflict with or contrary to this ordinance are hereby repealed, amended or modified accordingly.

Section 7. EFFECTIVITY CLAUSE.

This ordinance shall take effect after the approval of the Sangguniang Panlalawigan and after 15 days a copy hereof is posted in the bulletin board in the municipal hall and two other conspicuous places.
