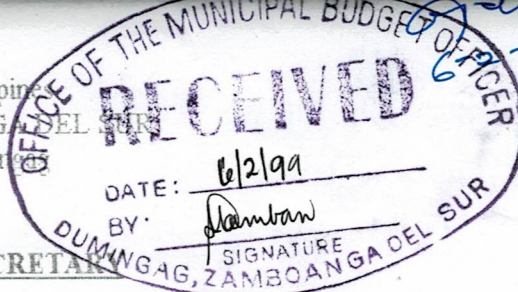

ORDINANCE No. 1, 1999

Personnel

" AN ORDINANCE CREATING A POSITION FOR TWO (2) COMMUNICATIONS
EQUIPMENT OPERATOR I IN THE OFFICE OF THE MUNICIPAL MAYOR FOR
THE MUNICIPAL COMMUNICATION SYSTEM AND PROVIDING FUNDS THEREFOR."

Be it enacted by the Sangguniang Bayan of Dumingag, Zamboanga del Sur, in
session assembled that:

Section 1. TITLE - This ordinance shall be called " AN ORDINANCE CREATING
A POSITION FOR TWO (2) COMMUNICATIONS EQUIPMENT OPERATOR I IN THE OFFICE OF
THE MUNICIPAL MAYOR AND PROVIDING FUNDS THEREFOR."

Section 2. CREATION - There is hereby created a position for two (2)
Communications Operator I in the Office of the Municipal Mayor for the mun-
icipal communications system.

Section 3. SALARY GRADE - The salary grade of the Communications Operator
I shall be SG 04, level I with salary of SIXTY SEVEN THOUSAND SEVEN HUNDRED
FIFTY TWO PESOS (₱67,752.00) per annum.

Section 4. DUTIES AND FUNCTIONS - The Communications Equipment Operator
I shall be the official Operator of the VHF/UHF/HF radio equipment/s of the
municipal communications system in transmission and reception of messages
and shall be responsible for the safety of such equipments during their
respective tour of duties. Perform such other related duties and functions
as may be prescribed by the Municipal Mayor or by law.

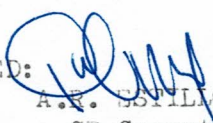
Section 5. APPROPRIATION - For this purpose, the municipal budget officer
shall prepare the corresponding supplemental budget to cover outlay for sala-
ries and other emoluments due for the two (2) positions specified in this
Ordinance, as well as, mandatory and statutory obligations to be shouldered
by the municipal government, which shall be reflected every year in the exe-
cutive budget.

Section 6. SEPARABILITY CLAUSE - Any section or provision of this Ordi-
nance which may declared unlawful or unconstitutional shall not affect the
other sections or provisions hereof.

Section 7. EFFECTIVITY CLAUSE - This Ordinance shall take effect after the review by the Sangguniang Panlalawigan.

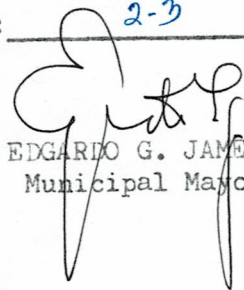
