Ordinance No. 1, s. 2009

AN ORDINANCE REQUIRING BUDDERS TO SECURE LICENSE BEFORE ENGAGING BUSINESS IN THE MUNICIPALITY OF DUMINGAG, ZAMBOANGA DEL SUR.

Be it ordained by the Sangguniang Bayan of Dumingag, Zamboanga del Sur in session assembled that:

Section 1. TITLE. This ordinance shall be called as "An Ordinance Requiring Budders To Secure License Before Engaging Business In The Municipality Of Dumingag, Zamboanga Del Sur."

Section 2. REGULATORY PROVISION. Only duly accredited and licensed budders shall be recognized and shall be permitted to engage in budding within the municipality.

Section 3. REQUIREMENTS. The interested individual must secure the following requirements:

1. Certification

A Certification shall be secured from the Municipal Agriculture Office which will be issued upon completion of BUDDER'S TRAINING and subsequently passing the minimum requirement of germination percentage of budded plants.

2. Mayor's Permit

A Mayor's Permit shall be secured. Requisite to this permit are Community Tax Certificate, Barangay Clearance and Police Clearance

3. Budder's License

A Budder's License must be secured from the Office of the Municipal Mayor which will be issued after a certification from the Municipal Agriculture Office and Mayor's permit shall be presented. This license shall be renewable every three years.

1. License fee	P200.00
2. Police Clearance	50.00
3. Mayor's permit fee	50.00

Section 5. PENAL PROVISION. Any person found guilty of violating any provision of this ordinance shall be fined as follows:

1. First Offense	P 250.00
2. Second Offense	500.00
3. Third & subsequent offenses	1,000.00

Section 6. IMPLEMENTING AGENCIES. The Office of the Municipal Agriculture, Office of the Municipal Mayor in coordination with the Philippine National Police (PNP) shall cause the effective and strict implementation of this ordinance.

Section 7. SEPARABILITY CLAUSE. If any provision or part hereof, is held invalid or unconstitutional, the remainder of the provision not otherwise affected shall remain valid and subsisting.

SECTION 5. EFFECTIVITY CLAUSE. This ordinance shall take effect after the approval of the Sangguniang Panlalawigan and after fifteen (15) days from the date copy hereof is posted in the Bulletin Board at the entrance of the Municipal hall and in at least two (2) other conspicuous places in the Poblacion and published in a local newspaper of general circulation once a week for three consecutive weeks, informing the constituents of the provisions and date of the effectivity thereof.
