ORDINANCE NO. 10, S. 1995

AN ORDINANCE REQUIRING THE CHAINSAW OPERATORS TO COMPLY THE REGULATORY ORDINANCE NO. 14 ENACTED BY THE SANGGUNIANG PANLALAWIGAN OF ZAMBOANGA DEL SUR AND FIXING THE FEES OF THE MAYOR'S PERMIT THEREOF. AUTHOR HONORABLE JUN PACALIOGA, CO-AUTHOR HONORABLE

WHEREAS, Regulatory Ordinance No. 14 regulates the purchase, ownership, possession and carrying of power saws;

WHEREAS, said ordinance although it seems revenue generator but is environmental friendly measure that aims primarily to protect our remaining ecological forest reserves and wildlife from any endangered ^{species} act such as illegal logging and smuggling of logs, illegal cutting of trees and other similar acts;

WHEREAS, pursuant to the provisions of the Regulatory Ordinance No. 14, only those operators or owners of chain saws who comply the requirements requisites as stated are considered legal;

NOW THEREFORE, in session assembled, be it ordained, as it is hereby ordained;

SECTION I - All chainsaw operators or owners are mandated to comply the requirements stated in the provisions of the Sangguniang Panlalawigan No. 14 such as securing the Governor's Permit, Mayor's Permit, Annual Regulatory Permit or License Fee, Permit to carry or Transport Power Saws and all power saws must be registered with the Municipal or Provincial Treasurer's Office.

SECTION II- MAYOR'S PERMIT - any person, association, corporation, partnership and other entities procuring a power saw shall first secure a Mayor's Permit by paying a fee in the amount of Fifty pesos (P 50.00).

SECTION III - ENFORCING AGENCY - The Philippine National Police and the Department of Environment Natural Resources (DENR) are hereby mandated to make more intensive action to strictly enforce this ordinance.

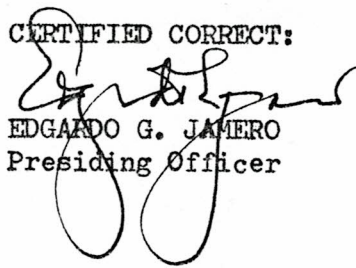
SECTION IV - SEPARABILITY AND REPEALING CLAUSES - Any section of provision of this ordinance which may be declared unlawful or unconstitutional shall not affect the other sections of provisions hereof.

All ordinances, resolution, or laws, of local effect inconsistent with the ordinance are hereby modified, superceded or repealed accordingly.

SECTION V - EFFECTIVITY - This ordinance shall take effect 15 days after its publication and upon approval by the Sangguniang Panlalawigan.
