ORDINANCE NO. 10, s. 1997.

"AN ORDINANCE ORDAINING A PROPER PROCEDURE IN THE ISSUANCE OF CERTIFICATION AND REGISTRATION OF LARGE CATTLE AND PROVIDING PENALTIES FOR ANY VIOLATIONS THEREOF." (Hon. Jun Pacalioga & Hon. Edman Ambil)

Be it ordained by the SB of Dumingag, Zamboanga del Sur in Session assembled that :

SECTION 1- TITLE - This ordinance shall be called "ORDAINING A PROPER PROCEDURE IN THE ISSUANCE OF CERTIFICATION AND REGISTRATION OF LARGE CATTLE AND PROVIDING PENALTIES FOR ANY VIOLATIONS THEREOF."

SECTION 2- PURPOSE - This ordinance aims to provide a proper procedure in the issuance of certification and registration of large cattle. Further pursuant to PD 533 known as ANTI-CATTLE RUSTLING LAW OF 1974 and to the provisions of the Local Government Code, this ordinance also serves as preventive measures from any lawlessness and dis-order that may future arise.

SECTION 3- DEFINITION OF TERMS - For purposes of his ordinance the following terms are defined as follows :

- a. Large Cattle - include cows, carabaos, horses.
- b. Owner/Raiser - a person who owns legally a large cattle and/or this include caretaker or employee of any form engaged in raising large cattle.
- c. Cattle Rustling - is the taking away by any means, methods or scheme, without the consent of the owner/raiser of any of the above-mentioned animals whether or not for profit or gain, or whether committed with or without violence againsts or intimidation of any person or force upon things.

SECTION 4- REGULATORY PROVISION - This ordinance provides following regulations :

- a) The Barangay Captain
 - 1. Prior to the issuance of a Barangay certification authenticating the ownership of such large cattle, he/she must see to it that the owner/raiser has in his possession or

ownership such as the registration of mother large cattle and/or any kind of evidence/witness confirming ownership.

2. Only the Barangay Captain concerned where the large cattle belongs can issue a certification certifying to the ownership of such large cattle.

b) The Municipal Treasurer or his duly authorized representative

1. Before registering large cattle, a certification from the Barangay Captain is required.

2. Must keep the compilation of record of the Barangay Certifications

SECTION 5 - PRESUMPTION - As a presumption, the Municipal Treasurer or his duly authorized representative and/or the Barangay Captain shall be liable for any untoward criminal and administrative cases implicated by them particularly of cattle rustling case from their being an issuing/registering officer.

SECTION 6 - CLEARANCE FEE - Any person, partnership, association, corporation or entity desiring to ship or transport large cattle from this municipality to another for whatsoever purposes shall secure a permit from the Municipal Mayor and pay the amount of TEN (P10.00) PESOS per animal.

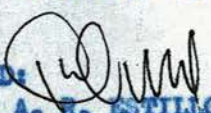
SECTION 7 - PENAL PROVISION - Any person found guilty of violating the next preceding paragraph shall be punished by a fine of not less than FIVE HUNDRED (P500.00) PESOS but not less than ONE THOUSAND (P1,000.00) PESOS. If a person is found guilty of violating section 4 of this ordinance same shall be punished administratively by his respective agency head/higher organization such as the Municipal Mayor in the case of the Municipal Treasurer or his duly authorized representative and the Sangguniang Bayan in the case of the Barangay Captain. In the conviction of any person as cattle rustler he shall be punished by the penalties under section 8 of PD 533 known as ANTI-CATTLE RUSTLING LAW of 1974.

SECTION 8 - SEPARABILITY CLAUSE - If any part or provisions of this ordinance shall be held unconstitutional or invalid, other part or provisions not affected thereby shall continue in full force and effect.

SECTION 9 - REPEALING CLAUSE - All resolutions, ordinances, laws of local effect inconsistent with this ordinance is hereby modified, repealed or superseded accordingly.

SECTION 10 - EFFECTIVITY CLAUSE - This ordinance shall take effect after the review of the Sangguniang Panlalawigan.
