ORDINANCE NO. 10, s. 1998

"AN ORDINANCE PROHIBITING ANY PERSONS IN THROWING WASTE MATERIALS IN ANY ROAD (NATIONAL, MUNICIPAL AND BARANGAY ROAD) ALLEYS, PUBLIC MARKET, PLAZAS AND PUBLIC LOTS AND PROVIDING PENALTY THEREOF."

Be it ordained by the Sangguniang Bayan of Dumanigag, Zamboanga del Sur that :

Section 1. Any person or persons are prohibited from throwing waste materials in any road (national, municipal and barangay road) alleys, public markets, plazas and pbulic lots.

Section 2. Any violation to the provisions of this ordinance shall subject the offender to a fine of ₱ 100.00 for the 1st offense, ₱ 200.00 for the 2nd offense and ₱ 300.00 for the 3rd offense, and /or imprisonment of not less than 5 days or both such fine and imprisonment at the discretion of the court.

Section 3. All ordinances which are inconsistent to the provision of this ordinance are hereby repealed.

Section 4. This ordinance shall take effect after posting certified true copies of the same duly approved by the Municipal Mayor at prominent places and in the Municipal Hall for a period of three (3) consecutive weeks.
