Ordinance No. 10, s. 2000

AN ORDINANCE CREATING THE POSITIONS OF ONE (1) MEDICAL OFFICER V, ONE (1) DENTIST IV AND ONE (1) SANITARY INSPECTOR V IN THE MUNICIPAL HEALTH OFFICE AND PROVIDING FUNDS THEREFOR.

Be it enacted by the Sangguniang Bayan of Dumingag, Zambo. Sur in session assembled that:

Section 1. TITLE - This ordinance shall be called "AN ORDINANCE CREATING POSITIONS OF MEDICAL OFFICER V, DENTIST IV AND SANITARY INSPECTOR V IN THE MUNICIPAL HEALTH OFFICE AND PROVIDING FUNDS THEREFOR."

Section 2. CREATION - There is hereby created positions to be included in the plantilla of personnel of the Local Government Unit (LGU) of Dumingag, Zamboanga del Sur under the Municipal Health Office, to wit:

Medical Officer V	22	P 335,052.96
Dentist IV	22	335,052.96
Sanitary Inspector	15	208,221.48

Section 3. APPROPRIATION - For this purpose, the Municipal Budget Officer shall prepare the corresponding supplemental budget to cover outlay for the salaries and other emoluments due for the created positions as provided for in Section 2 hereof, as well as mandatory and statutory obligations to be shouldered by the municipal government, which shall be reflected every year in the Executive Budget.

Section 4. SEPARABILITY CLAUSE - Any section or provisions of this ordinance which may be declared unlawful or invalid, the remainder of such declarations shall remain to be in full force and effect.

Section 5. EFFECTIVITY - This ordinance shall take effect after the review by the Sangguniang Panlalawigan.
