ORDINANCE NO. 11, s. 1998

" AN ORDINANCE REQUIRING ALL EDUCATIONAL AND OTHER SIMILAR INSTITUTIONS, WHETHER PUBLIC OR PRIVATE, ALL COMMERCIAL AND INDUSTRIAL ESTABLISHMENT SUCH AS HOTELS, RESTAURANTS, HOSPITALS CINEMA HOUSES, PUBLIC MARKETS, DEPARTMENT STORES, GROCERIES AND THE LIKE, ALL PUBLIC CONVEYANCES : ALL RESIDENTIAL HOUSES AND ALL OTHER SIMILAR ESTABLISHMENTS WITHIN THE MUNICIPALITY OF DUMINGAG ZAMBOANGA DEL SUR TO PROVIDE THEIR OWN CONTAINER FOR PROPER DISPOSAL OF ANY KIND OF TRASH AND PROVIDING PENALTY FOR VIOLATION THEREOF."

Be it Ordained by the Sangguniang Bayan of Dumingag, Zamboanga del Sur, that :

Section 1. All educational and other similar institutions, whether public or private, all commercial and industrial establishments, such as hotels, restaurants, hospitals, cinema houses, public market, department stores, groceries and the like : all public conveyances : all residential houses and all other similar establishments shall place a plastic trash can in front of their houses, business establishments or at a designated area and keeping it close all the time for sanitation purposes.

Section 2. All garbage, and other waste materials shall be placed on the above-mentioned container for the collection and disposal thereof by the garbage collectors.

Section 3. Any person/persons violating the provisions of this ordinance shall subject the offender a fine of not less than ₱ 500.00 pesos but not more than ₱ 1,000.00 pesos and an imprisonment of not less than 5 days but not more than 10 days, or both such fine and imprisonment upon the discretion of the court.

Section 4. Any ordinance, which is inconsistent with the provision of this ordinance are here by repealed.

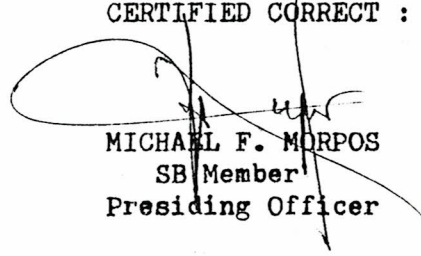
Section 5. Effectivity - This ordinance shall take effect ten days after approval.

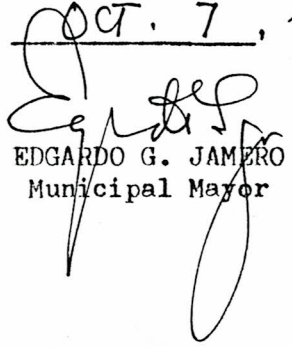
