Ordinance No. 11, s. 2000

AN ORDINANCE CREATING THE POSITIONS OF ONE (1) SENIOR AGRICULTURIST AND ONE (1) ANIMAL KEEPER IN THE MUNICIPAL AGRICULTURE OFFICE.

Be it enacted by the Sangguniang Bayan of Dumingag, Zambo. Sur in session assembled that:

Section 1. TITLE - This ordinance shall be called "AN ORDINANCE CREATING TWO POSITIONS OF MUNICIPAL AGRICULTURE OFFICE."

Section 2. CREATION - There is hereby created positions of one (1) Senior Agriculturist and one (1) Animal Keeper to be included in the plantilla of personnel of the Local Government Unit (LGU) of Dumingag, Zamboanga del Sur under the Municipal Agriculture Office.

Section 3. SALARY GRADE - The salary grade of Senior Agriculturist shall be SG 18 and Animal Keeper shall be SG 4.

Section 4. APPROPRIATION - The annual salary and other emoluments due for the created positions shall be ONE HUNDRED EIGHTY ONE THOUSAND AND FORTY FOUR PESOS for the item - SENIOR AGRICULTURIST and SEVENTY FOUR THOUSAND FIVE HUNDRED THIRTY TWO (P74,532) for the item - ANIMAL KEEPER, which shall be reflected every year in the Executive Budget as well as mandatory and statutory obligations to be shouldered by the municipal government.

Section 5. SEPARABILITY CLAUSE - Any section or provisions of this ordinance which may be declared unlawful or invalid, the remainder of such declarations shall remain to be in full force and effect.

Section 6. EFFECTIVITY - This ordinance shall take effect after the review by the Sangguniang Panlalawigan.
