Municipal Ordinance No. 11th-3-2022

AN ORDINANCE AMENDING SECTION 38, ARTICLE VIII OF MUNICIPAL ORDINANCE NO. 8, S. 2020 OTHERWISE KNOWN AS THE TRAFFIC MANAGEMENT CODE OF DUMINGAG, ZAMBOANGA DEL SUR.

SECTION 1. RATIONALE

Municipal Ordinance No. 8, s. 2020 otherwise known as the Traffic Management Code of Dumingag was duly approved by the Sangguniang Bayan of Dumingag last August 18, 2020. One of the salient provisions of the Traffic Management Code is the declaration of portion of Isidoro Y. Real Sr. Street: from Corner San Jose St. to Corner Lapu-lapu St. and portion of Lapu-lapu St. (Barangay San Pablo): from corner Isidoro Y. Real Sr. St. to corner Magsaysay Avenue as one-way streets. The use of the one-way streets shall be permissible from five in the morning (5:00 a.m.) to eight in the evening (8:00 p.m.).

Because of the inconvenience the one-way streets caused to the motorists, pedestrians and residents living near the aforementioned streets, there is a growing public clamor to revert back the use of the streets for two-way traffic.

SECTION 2. AMENDMENTS

Section 38, Article VIII of Municipal Ord. No. 8, s. 2020 is hereby amended to delete Paragraph 1 which will pave the way for a two-way traffic of portion of Isidoro Y. Real Sr. Street: from Corner San Jose St. to Corner Lapu-lapu St. and portion of Lapu-lapu St. (Barangay San Pablo): from corner Isidoro Y. Real Sr. St. to corner Magsaysay Avenue.

Paragraph 2 shall also be amended to read as follows;

The Traffic Enforcement & Management Council (TEMC) and/or Traffic Enforcement & Management Office (TEMO), in consultation with the Dumingag PNP and with the approval of the Municipal Mayor shall make recommendations to the Sangguniang Bayan of Dumingag as to what municipal street shall be declared for one-way traffic. If no action is taken by the Sanggunian within three months from the date the proposal was received, the same shall be deemed approved as part and parcel of this Ordinance.

SECTION 3. EFFECTIVITY

This Ordinance shall take effect immediately upon its approval.
