Municipal Ordinance No. 11th-7-2023

AN ORDINANCE AMENDING THE SPEED LIMIT IN SPECIFIC PLACES AS DEFINED IN ARTICLE VII, SECTION 34 (B) OF MUNICIPAL ORDINANCE NO. 8, S. 2020 OTHERWISE KNOWN AS THE TRAFFIC MANAGEMENT CODE OF THE MUNICIPALITY OF DUMINGAG, ZAMBOANGA DEL SUR AND FOR OTHER PURPOSES.

SECTION 1. TITLE

This Ordinance shall be called "An ordinance amending the speed limit in specific places as defined in Article VII, Section 34 (b) of Municipal Ordinance No. 8, s. 2020 otherwise known as the Traffic Management Code of the municipality of Dumingag, Zamboanga del Sur and for other purposes."

SECTION 2. RATIONALE

This ordinance retains the original policy and intent outlined in Municipal Ordinance No. 8, s. 2020. However, there shall be an expansion and clearer definition of the locations where speed limit provisions will be enforced.

In adherence to the existing Land Transportation Office (LTO) laws and regulations, Department of Interior and Local Government (DILG) - Department of Transportation and Communication (DOTC) Joint Memorandum Circular No. 01-2008 and DILG Memorandum Circular dated September 14, 2022, reiterating that the LGUs can issue a citation ticket but only the Land Transportation Office (LTO) and its duly deputized agents can confiscate driver's licenses, the penalty of driver's license confiscation in Mun. Ord. No. 8, s. 2020 will be deleted.

SECTION 3. AMENDMENTS

A. Article VII, Section 34 (b) of Municipal Ordinance No. 8, s. 2020 shall be amended to read as follows;

Subject to the provisions of the preceding paragraph, all types of motor vehicles shall not exceed the specified speed limit given in the following, to wit;

PLACES	SPEED LIMIT
In all streets within the Poblacion area	30 kph
In approaching a pedestrian lane	20 kph
In approaching an intersection	20 kph
In all school zones (50 meters from the designated pedestrian lane)	20 kph
Guitrán - Mahayag Boundary to Poblacion	30 kph
Sitio Tumoy bridge to Poblacion	30 kph

New Basak - NAWASA to Poblacion	30 kph
Caridad - Barangay Hall to Poblacion	30 kph
Mahayahay - Lunas - Purok II to Poblacion	30 kph
Libertad - Western Mindanao Academy to Poblacion	30 kph
NIA Road - Caridad to Poblacion	30 kph

B. In adherence to existing laws, LTO and DILG memorandum circulars regarding driver's license confiscation, Municipal Ordinance No. 8, s. 2020 shall also be amended to include the following, to wit;

1. Article XII, Section 66 and Section 67 shall be amended to delete the penalty of driver's license confiscation.
2. In Article XXIII, Section 140, confiscation of driver's license shall be deleted in the issuance of citation tickets procedures.
3. The second paragraph in Article XXIII, Section 145 shall be deleted as it provides for the procedure in redeeming the confiscated driver's license.
4. In Article XXIV, Section 158 (b) and (d), confiscation and the keeping of driver's license shall be deleted as part of the powers, duties and responsibilities of the Traffic Enforcement and Management Office (TEMO).

SECTION 4. SEPARABILITY CLAUSE

If any portion of this ordinance is declared invalid or unconstitutional, other portions hereof not affected by such declaration shall remain in full force and effect.

SECTION 5. REPEALING CLAUSE

Any portion of an ordinance, order or memorandum of local effect inconsistent with the provision/s of this ordinance is hereby repealed or modified accordingly.

SECTION 6. EFFECTIVITY CLAUSE

This ordinance shall take effect after fifteen (15) days following the completion of the posting requirements in three (3) conspicuous places in the municipality of Dumingag and its publication in any newspaper of general circulation or posting of copies in all the municipalities and one (1) city within the province of Zamboanga del Sur.
