Municipal Ordinance No. 11th-9-2024

AN ORDINANCE AMENDING THE PLANTILLA POSITION TITLE “BOARD SECRETARY” TO “BOARD SECRETARY I” IN THE OFFICE OF THE SANGGUNIAN BAYAN UNDER MUNICIPAL ORDINANCE NO. 1, S. 2022 OTHERWISE KNOWN AS THE UPDATED ORGANIZATIONAL STRUCTURE/STAFFING PATTERN OF LGU DUMINGAG FOR 2022.

Be it ordained by the Sangguniang Bayan in session assembled that:

SECTION 1. TITLE

This Ordinance shall be called “An ordinance amending the plantilla position title “Board Secretary” to “Board Secretary I” in the Office of the Sangguniang Bayan under Municipal Ordinance No. 1, s. 2022 otherwise known as the Updated Organizational Structure/Staffing Pattern of LGU Dumingag for 2022.

SECTION 2. RATIONALE

This ordinance retains the original provisions and intent outlined in Municipal Ordinance No. 1, S. 2022. However, it necessitates an amendment to one (1) specific position title within the Office of the Sangguniang Bayan.

Justification for this amendment stems from an administrative oversight wherein the position title was inaccurately inputted. Rather than designating the position as “Board Secretary I”, it was erroneously entered as “Board Secretary,” rendering it non-compliant with the prescribed standards. Amending the authorized position title of “Board Secretary” to “Board Secretary I” now aligns with the classifications set forth by the Department of Budget and Management (DBM) in its Index of Occupational Services.

SECTION 3. AMENDMENT

Section 3 of Municipal Ordinance No. 1, s. 2022 particularly under the Office of the Sangguniang Bayan, shall be amended to read as follow:

SECTION 4. SEPARABILITY CLAUSE

If any portion of this ordinance is declared invalid or unconstitutional, other portions hereof not affected by such declaration shall remain in full force and effect.

SECTION 5. REPEALING CLAUSE

Any portion of an ordinance, order or memorandum of local effect inconsistent with the provision/s of this ordinance is hereby repealed or modified accordingly.

SECTION 6. EFFECTIVITY

This Ordinance shall take effect upon its approval.
