AN AMENDATORY ORDINANCE REQUIRING ALL LARGE CATTLE OWNERS TO REGISTER THEIR LARGE CATTLE TO THE TREASURER'S OFFICE, DUMINGAG, ZAMBOANGA DEL SUR AND PROVIDING REQUIREMENTS FOR PROPER PROCEDURES OF ISSUANCE OF REGISTRATION AND FEES THEREOF."

Section I. TITLE.

This ordinance shall be called "An Amendatory Ordinance Requiring All Large Cattle Owners to Register Their Large Cattle to the Treasurer's Office, Dumingag, Zamboanga del Sur And Providing Requirements For Proper Procedures of Issuance of Registration And Fees Thereof."

Section II. DECLARATION OF POLICY.

It is the policy of the municipality of Dumingag, Zamboanga del Sur to ensure that all large cattle has its individual identity and shall be given individual certificate of ownership to account all large animals in this municipality.

Section III. PURPOSE.

The purpose of this ordinance is to:

1. Ensure that all draft animals are duly registered in this municipality.
2. Ensure that all draft animals bears individual certificate of ownership.
3. To avail the benefits from the government intended for the livestock such as mass vaccination treatment, deworming, and others.
4. Increase Municipal income.
5. For easy identification and avoid misidentification.

Section IV. REQUIREMENTS FOR REGISTRATION.

1. Three (3) copies barangay certification certifying the ownership and description of large cattle.
2. Appearance of large animal for cowlick identification
3. A fee of:
 - a. Eighty Pesos (P80.00) (during every mass vaccination/treatment) and Five Pesos (P5.00) for the issuance of the certificate of ownership.
 - b. One Hundred Pesos (P100.00) (individual/private request) for register and ten pesos (P10.00) for the issuance of the certificate of ownership.

Section VI. MECHANICS FOR IMPLEMENTATION.

Before the registration, the owner shall secure a certification from the Barangay Captain in Three (3) copies, certifying ownership, gender, age and color of draft animal. Appearance of animal is being required for cowlicks identification.

During mass vaccination, an eighty pesos (P80.00) is being collected for individual owner/large cattle for a registration fee and five pesos (P5.00) for the issuance of certificate of ownership.

For the issuances of certificate of transfer, ten pesos (P10.00) shall be collected/owner/large cattle. If, in every individual/private registration is requested, a fee of one hundred pesos (P100.00) pesos shall be collected to individual owner.

Section VII. REQUIRING PROVISIONS.

1. All owners of draft animals in this municipality are required to register their draft animals to the Treasurer's Office, Dumingag, Zamboanga del Sur. Six (6) months from birth or less than one (1) year.
2. Unregistered draft animal owners are not entitled/allowed to a free mass vaccination, treatment and deworming from the government.

Section VIII. IMPLEMENTING GUIDELINES.

The Municipal Mayor shall make other necessary guidelines for proper and effective implementation of this ordinance in an executive order which shall be issued for this purpose.

Section IX. SEPARABILITY CLAUSE:

Any provision of this ordinance or parts thereof declared unconstitutional or unlawful, the other parts not affected shall remain in full force and effect.

Section X. REPEALING CLAUSE:

Any parts or provisions of this ordinance in conflict with or contrary to the existing ordinance are hereby repealed, amended or modified accordingly.

Section XI. EFFECTIVITY:

This ordinance shall take effect after the approval of the Sangguniang Panlalawigan and after fifteen (15) days from the date copy hereof is posted in the bulletin board at the entrance of the municipal hall and at least two (2) other conspicuous places in the Poblacion.

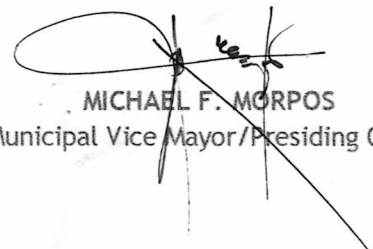

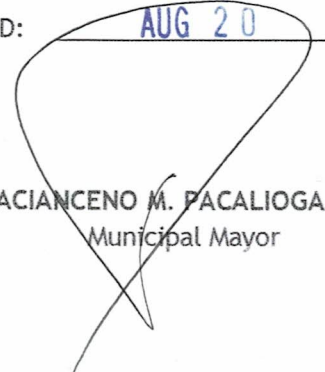
