Ordinance No. 12, 1999

"AN ORDINANCE CREATING THE POSITIONS OF TWO (2) DRIVER I AND ONE (1) TICKET CHECKER II IN THE OFFICES OF THE MUNICIPAL MAYOR AND MUNICIPAL TREASURER, RESPECTIVELY AND PROVIDING FUNDS THEREFOR."

Be it enacted by the Sangguniang Bayan of Dumingag, Zamboanga del Sur in session assembled :

Section 1. TITLE - This Ordinance shall be called " AN ORDINANCE CREATING POSITIONS OF TWO (2) DRIVER I AND ONE (1) TICKET CHECKER II IN THE OFFICES OF THE MUNICIPAL MAYOR AND MUNICIPAL TREASURER, RESPECTIVELY AND PROVIDING FUNDS THEREFOR."

Section 2. CREATION - There is hereby created positions to be included in the plantilla of personnel of the Local Government Unit (LGU) of Dumingag, Zamboanga del Sur for Driver I and Ticket Checker II under the offices of the municipal mayor and municipal treasurer, respectively, to wit :

1	Ticket Checker II	3/1	₱62,736.00

Section 3. APPROPRIATION - For this purpose, the municipal budget officer shall prepare the corresponding supplemental budget to cover outlay for the salaries and other emoluments due for the created positions as provided for in Section 2 hereof, as well as mandatory and statutory obligations to be shouldered by the municipal government, which shall be reflected every year in the Executive Budget.

Section 4. SEPARABILITY CLAUSE - Any section or provision of this Ordinance which may be declared unlawful or invalid, the remainder of such declaration shall remain to be in full force and effect.

Section 5. EFFECTIVITY CLAUSE - This Ordinance shall take effect after the review by the Sangguniang Panlalawigan.
