ORDINANCE NO. 13, s. 1998

"AN ORDINANCE CREATING AT THE VICE MAYOR'S OFFICE THE ITEMS OF LEGISLATIVE STAFF ASST. 2, SECRETARY 1 AND LOCAL LEGISLATIVE EMPLOYEE 2 AND PROVIDING FUNDS THEREFOR."

Be it enacted and ordained by the Sangguniang Bayan, in session assembled :

Section 1 - There is hereby created at the Office of the Vice Mayor, new items, as follows :

Legislative Staff Asst. 2 - Grade 8
Secretary I - Grade 7
Local Leg. Staff Employee 2 - Grade 4

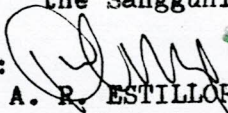
Section 2 - The said items created shall be indicated as Item Nos. _____, _____ and _____, in the Plantilla of the Vice Mayor's Office.

Section 3 - The Budget Officer shall prepare the necessary Supplemental Budget to cover outlay for salaries and other monies due the positions.

Section 4 - Any section or provision of this ordinance which may be declared unlawful or unconstitutional shall not effect the other sections or provisions hereof.

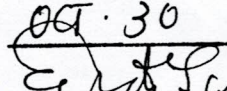
Section 5 - All ordinances, resolutions or laws of local effect inconsistent herewith are repealed.
