Ordinance No. 14-R, s. 2009

AN ORDINANCE ESTABLISHING A LITERACY PROGRAM FOR ADULTS AND SUBANEN CHILDREN IN THE MUNICIPALITY OF DUMINGAG, ZAMBOANGA DEL SUR.

Be it ordained by the Sangguniang Bayan of Dumingag, Zamboanga del Sur in session assembled that:

Section 1. **TITLE.** This ordinance shall be called as "AN ORDINANCE ESTABLISHING A LITERACY PROGRAM FOR ADULTS AND SUBANEN CHILDREN IN THE MUNICIPALITY OF DUMINGAG, ZAMBOANGA DEL SUR."

Section 2. **PURPOSE.** The Local Government Unit is committed to capacitate and to liberate people of Dumingag from illiteracy through the institutionalization of literacy program. This program aimed at raising the capacity of adults and Subanen children to be actively part of the mainstream of society while retaining their cultural values.

Section 3. **COMPONENTS.** The literacy program has two components: the Early Childhood Education Program (ECEP-Subanao Program) and Special Literacy Program (SLP)- Adult Literacy Program.

Section 4. IMPLEMENTING GUIDELINES.

Early Childhood Education Program (ECEP Subano)

- This is a program that teaches basic tools/skills of literacy such as reading, writing and counting. Awareness and revitalization of Subanen cultural values, beliefs and practices are integrated in the curriculum.
- A Para-Teacher shall be assigned in each community schools whose main task is to teach the Subanen children based on the module provided for. Para-Teachers who are mostly Subanen shall undergo series of trainings to equip them with basic skills and knowledge in teaching. A Para-teacher shall receive a monthly honorarium from both municipal and barangay government.
- Supplemental feeding is incorporated in the program.

Special Literacy Program (SLP) - adult literacy program

- This is a program that teaches basic tools/skills of literacy such as reading, writing and counting. Its main objective is to raise the capacity of illiterate adults to comprehend seminar inputs, internalize the program and participate in the economic development program of the LGU.
- A Learning Facilitator shall be assigned in each community whose main task is to teach the adult Subanen based on the module provided for. The Learning Facilitator shall undergo series of trainings to equip them with basic skills and knowledge in teaching. A Learning Facilitator shall receive a monthly honorarium from both municipal and barangay government.

Section 6. **IMPLEMENTING OFFICES.** It shall be the responsibility of the Office of the Municipal Mayor and Municipal Planning and Development Coordinator to oversee the implementation of the program in coordination with the Department of Education, Non-Government Organizations and other government agencies. .

Section 7. **SEPARABILITY CLAUSE.** If any provision or part hereof, is held invalid or unconstitutional, the remainder of the provision not otherwise affected shall remain valid and subsisting.

Section 8. **EFFECTIVITY CLAUSE.** This ordinance shall take effect upon the approval of the Sangguniang Panlalawigan and after 15 days from the date copy hereof is posted in the bulletin board at the entrance of the municipal hall and at least two (2) other conspicuous places in the Poblacion.

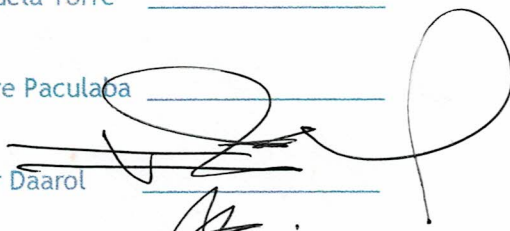

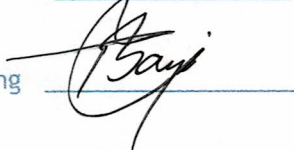
