ORDINANCE NO. 14, s. 1998

" AN ORDINANCE PROHIBITING ANY PERSON/PERSONS FROM CATCHING SPIDERS, EXCEPT DOMESTIC OR HOUSE SPIDERS, THUS TO CONTROL THE RAPID MULTIPLICATION OF MOSQUITOES AND PROVIDING PENALTY THEREOF."

WHEREAS, spiders help control the rapid multiplication of mosquitoes, thus spiders catch 25-30 mosquitoes a day ;

WHEREAS, mosquito is the most harmful insect that kills a person and destroys the health condition of our constituents, it is the carrier of diseases ;

WHEREAS, mosquitoes affect the farm production of our farmers because it bites and harms our working animals like the carabao, cow, horse, etc., that often results to low physical resistance ;

WHEREAS, casualties of dengue fever are increasing and these were found to be due to mosquito bites ;

NOW, THEREFORE, be it ordained by the Sangguniang Bayan, Dumingag, Zamboanga del Sur, in session assembled that :

Section I - Title : This ordinance shall be called "AN ORDINANCE PROHIBITING ANY PERSON/PERSONS FROM CATCHING SPIDERS THUS, TO CONTROL THE RAPID MULTIPLICATION OF MOSQUITOES AND PROVIDING PENALTY THEREOF".

Section 2 - Purpose : This ordinance aims to protect the health conditions of the constituents and promote the economic growth of our municipality.

a) Protection of spiders contributes a lot for the development of our municipality, socially, economically and health-wise.

b) Considering the new vision of the administration to promote/provide a better standard of living of the constituents through sufficient food sup-

ply by adopting modern technological farming, the farmers being the backbone of the nation.

- c) Pursuant to Section 16 of R.A. 7160, as the legislative body of the municipality, introducing health measures calculated to protect the constituents is in order.
- d) Without the involvement and cooperation of everyone, such measures are bound to fail.

Section 3 - General Provision - Any person/persons are prohibited to catch spiders thus to control the rapid multiplication of mosquitoes and providing penalty thereof.

Section 4 - Enforcement Agency - The Philippine National Police through its municipal stations shall enforce this ordinance at all times. All barangay officials concerned are enjoined to enforce this ordinance in their respective area of responsibility.

Section 5 - Penal Provisions - Any person/persons found violating this ordinance shall be dealt with accordingly:

- a) First Offense - a penalty of ₱100.00 or imprisonment of not less than one (1) week or both such fine and imprisonment at the discretion of the court.
- b) Second Offense - a penalty of ₱200.00 or imprisonment of not less than one (1) week, or both such fine and imprisonment at the discretion of the court.
- c) Third Offense - a penalty of ₱300.00 or imprisonment of not less than one (1) week or both at the discretion of the court.

Section 6 - Promulgating Guidelines - The LGU through the Municipal Mayor with the active participation of the public, will initiate measures and promulgate guidelines for the protection of spiders as embodied in this ordinance.

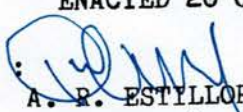
Section 7 - Repealing Clause - Any previous resolution or ordinance or laws of local effect not in consonance or inconsistent hereof is hereby repealed.

Section 8 - Separability Clause - Any section or provision of this ordinance which may be declared invalid, unlawful or unconstitutional, shall not disturb the other effective sections or provisions which shall remain in full force and effect.

Section 9 - This ordinance shall take effect after the review and approval of the Sangguniang Panlalawigan and three (3) consecutive weeks of posting at conspicuous places of the municipality, and another at the municipal hall.
