Ordinance No. 14, 1999

AN ORDINANCE CREATING AT THE MUNICIPAL ENGINEER'S OFFICE THE ITEM
OF ENGINEER - IV AND PROVIDING FUNDS THEREFOR.

Be it enacted by the Sangguning Bayan of Dumingag, Zamboanga del Sur
in session assembled that :

Section 1. TITLE - This Ordinance shall be called "AN ORDINANCE
CREATING AT THE MUNICIPAL ENGINEER'S OFFICE THE ITEM OF ENGINEER - IV
AND PROVIDING FUNDS THEREFOR."

Section 2. CREATION - There is hereby created a position, to be inclu-
ded in the plantilla of personnel of the Local Government Unit (LGU) of
Dumingag, Zamboanga del Sur, under the Office of the Municipal Engineer.

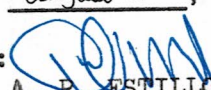
Section 3. SALARY GRADE - The salary grade of Engineer - IV shall
be SG 22, level I with salary of two hundred thousand four pesos (P200,004.00)
per annum.

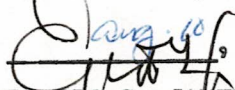
Section 4. APPROPRIATION - For this purpose, the Municipal Budget Officer
shall prepare the corresponding supplemental Budget to cover outlay for the
salaries and other emoluments due for the created position as well as manda-
tory and statutory obligations to be shouldered by the Municipal Government,
which shall be reflected every year in the Executive Budget.

Section 5. SEPARABILITY CLAUSE - Any section or provision of this Ordi-
nance which may be declared unlawful or invalid, the remainder of such dec-
laration shall remain to be in full force and effect.

Section 6. EFFECTIVITY CLAUSE - This Ordinance shall take effect
after the review by the Sangguniang Panlalawigan.
