ORDINANCE NO. 15, S. 1990

Introduced by Kagawad Macabinta & Kagawad Lladones

AN ORDINANCE FIXING AND/OR REGULATING THE PERIOD OF STAY
AMONG BARATILLO VENDORS WITHIN THE MUNICIPALITY OF DUMI-
NGAG, ZAMBOANGA DEL SUR TO 45 DAYS ONLY.

Be it ordained by the Sangguniang Bayan of Dumingag, Zamboanga del Sur,
that :

Sec. 1. There is hereby fixed a maximum period within which the
Baratillo vendors shall be allowed to stay in Dumingag covering the period
from February 15 to March 31 every year.

Sec. 2. That all Baratillo vendors shall pay to the Municipality of
Dumingag, Zamboanga del Sur the amount of ₱ 75.00 per square meter of the
space they will have to occupy.

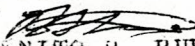
Sec. 3. Any person who violates this ordinance shall upon conviction
by a court of competent jurisdiction be punished by a fine of not less than
₱100 nor more than ₱200.00 or be imprisoned for not less than 5 days nor
more than 10 days or both fine and imprisonment at the discretion of the
court.

Sec. 4. Any previous ordinance, inconsistent with the provisions hereof
are deemed modified and/or repealed accordingly.

Sec. 5. This ordinance shall take effect immediately upon approval.

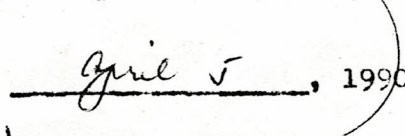
