Ordinance No. 15, s. 1999

**AN ORDINANCE AMENDING BY INSERTION THE MUNICIPAL
REVENUE CODE PARTICULARLY ARTICLE O, CHAPTER III.**

Be it enacted by the Sangguniang Bayan of Dumingag, Zamboanga del Sur in session assembled that :

Section 1. Title of Article O, Chapter III of the Revised Municipal Revenue Code is hereby amended by insertion, to read as follows :

TITLE : Article O. Permit to Purchase and Possess Firearms.

Section 2. Section 3O. 01 of Article O, Chapter III of the Revised Municipal Revenue Code is hereby amended by insertion, to read as follows :

Section 3O. 01. Imposition of fee. a) There shall be collected a Mayor's Permit Fee of P40.00 per unit from every applicant who intends to purchase firearm/s.

Section 3. Section 3O. 05 of Article O, Chapter III is hereby amended by insertion, to read as follows :

Section 3O. 05 Administrative Provision. Every resident of this municipality who is applying to purchase and/or possess firearms or who has been authorized to purchase and/or possess a firearms by the authorities thru a regular license or special permit shall apply for a Mayor's permit, thru the Chief of Police who shall register and record the name in a registry book for the purpose, renewal on the birth month of the licensee or permittee. The Chief of Police shall promulgate rules and regulations for the proper registration of all firearms subject to existing laws and regulation on the carrying of firearms outside residence .

Section 4. Any part or provision of this amendatory ordinance which may be declared unlawful, the other parts provisions hereof not affected thereby shall remain to be in full force and effect.

Section 5. This ordinance shall take effect upon review and approval by the Sangguniang Panlalawigan.

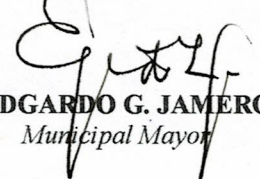
