**AN ORDINANCE DECLARING A NO-DOUBLE-PARKING POLICY UPON ALL
VEHICLES ON ALL MUNICIPAL STREETS OF DUMINGAG, ZAMBOANGA DEL SUR.**

Section 1. TITLE. This ordinance shall be known and cited as the "NO DOUBLE PARKING" law of Dumingag.

Section 2. AUTHORITY AND PURPOSE. The Sangguniang Bayan has the power to regulate traffic on all streets within its jurisdiction. Therefore, the objectives of this ordinance is to regulate all municipal streets in order to have a good traffic flow and to avoid occurrence of accidents and to some extent, loss of lives.

Section 3. DEFINITION OF TERMS. For purposes of this ordinance, the following terms shall mean:

- a. Double Parking - to park (a car or vehicle) alongside another vehicle already parked parallel to a curve.*
- b. Curve - a bounding without angles*
- c. Traffic - the business of moving passenger and cargo by means of transportation facilities.*
- d. Accident - unexpected and undesirable event.*
- e. Extent - the distance over which a thing extends or the space occupies.*
- f. Regulate - to control or direct according to a rule.*

Section 4. REGULATORY PROVISIONS. There is hereby declared a NO-DOUBLE-PARKING POLICY UPON ALL VEHICLES on all municipal streets of Dumingag.

Section 5. ENFORCEMENT AGENCY. The Municipal Police Station through its traffic officers shall strictly enforce this ordinance at all prescribed times.

Section 6. PENAL PROVISIONS. Any driver found guilty of violating this ordinance shall, upon conviction, be penalized accordingly.

- a. For motor vehicles*

1. First offense - a fine of fifty pesos (P50.00) or an imprisonment of five (5) days or both at the discretion of the court.
2. Second offense - a fine of one hundred pesos (P100.00) or an imprisonment of ten (10) days or both at the discretion of the court.
3. Third and succeeding offenses - a fine of two hundred pesos (P200) or an imprisonment of not less than one (1) month but not more than three (3) months or both at the discretion of the court.

b. For tri-sikad drivers

1. First offense - a fine of ten pesos (P10.00) or an imprisonment of two (2) days or both at the discretion of the court.
2. Second offense - a fine of thirty pesos (P30.00) or an imprisonment of five (5) days or both at the discretion of the court.
3. Third and succeeding offenses - a fine of fifty pesos (P50.00) or an imprisonment of three (3) months or both at the discretion of the court.

c. For commercial and private vehicles

First and succeeding offenses - a fine of one hundred pesos (P100.00) or an imprisonment of two (2) days or both at the discretion of the court.

Section 7. **SEPARABILITY CLAUSE.** If any part or provision of this ordinance may be declared invalid or unconstitutional, the remaining portions not affected by such declaration shall remain in full force and effect.

Section 8. **REPEALING CLAUSE.** Any previous resolutions or ordinances inconsistent hereof is/are hereby modified, repealed or superseded accordingly.

Section 9. **EFFECTIVITY.** This ordinance shall take effect after review and approval of the Sangguniang Panlalawigan and after fifteen (15) days from the date copy hereof is posted in the Bulletin Board at the entrance of the municipal hall and in at least two (2) other conspicuous places in the Poblacion and further, announcement in the local Cable TV, informing the constituents of the provisions and date of effectivity thereof.

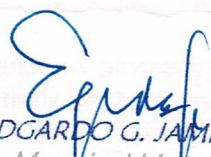
