Ordinance No. 15, s. 2002

AN ORDINANCE MANDATING DOG OWNERS TO TIE/KEEP THEIR PET DOGS IN THEIR RESPECTIVE PREMISES/COMPOUND WITHIN THE MUNICIPALITY OF DUMINGAG, ZAMBOANGA DEL SUR AND PROVIDING PENALTIES FOR VIOLATION THEREOF."

WHEREAS, it is the prime duty of every dog owner to provide food, shelter and care of his pet dog;

WHEREAS, it is also their responsibility and obligation to tie/keep their pet dog in their respective premises/compound to protect every individual especially children who are very vulnerable to dog bites.

NOW, THEREFORE, this body hereby adopts as it is hereby adopted:

Section 1. TITLE. "Ordinance Mandating Dog Owners to Tie/Keep Their Pet Dogs in Their Respective Premises/Compound within the Municipality of Dumingag, Zamboanga del Sur."

Section 2. SCOPE OF APPLICATION. This ordinance shall be applied to all dog owners in the municipality of Dumingag, Zamboanga del Sur.

Section 3. PURPOSE. The purpose of this ordinance is:

1. To keep/save the people from any possible dog bite especially the children.
2. To keep us free from rabid dogs
3. To keep our environment clean and dog excreta-free

Section 4. DEFINITION OF TERMS

1. *Rabies* - an acute, infectious viral diseases transmitted by the bite of an infected animal.
2. *Pet dogs* - dogs kept inside the premises of the owner
3. *Stray Dogs* - wandering dogs roaming around the public/streets or anywhere

Section 5. MANDATORY PROVISIONS¹

1. Any dog owner/s mandated to tie/keep their dogs in their respective premises/compound.
2. Pet dogs found roaming around or outside the premises of the pet dog owners shall be declared stray dogs.
3. All dog owners are hereby mandated to shoulder the cost of medication of dog bite victim(s) especially if the biting dog shows signs of being positive of rabies as provided for in Section 1 of Ordinance #12, s. 1996.
4. Stray dogs found inside the premises of another home owner, the latter is mandated to report to the Dumingag Philippine National Police for immediate action.

Section 6. PENAL PROVISION. Any dog owner found violating this ordinance shall be fined of P1,000.00 and or 30 days imprisonment, or both at the discretion of the court.

Section 7. SEPARABILITY CLAUSE. If any portion or section of this ordinance is declared void or unconstitutional, the remaining portions thereof not affected by such declaration shall remain in full force and effect.

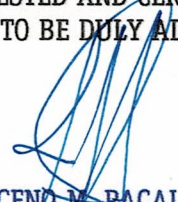
Section 8. EFFECTIVITY AND PUBLICATION CLAUSE. This ordinance shall take effect after the approval of the Sangguniang Panlalawigan and after fifteen (15) days from the date copy hereof is posted in the bulletin board at the entrance of the municipal hall and in at least two (2) other conspicuous places in the Poblacion, announcement in the Local Cable TV, and FM stations and further, published in a local newspaper of general circulation once a week for three consecutive weeks, informing the constituents of the provisions and date of effectivity hereof.

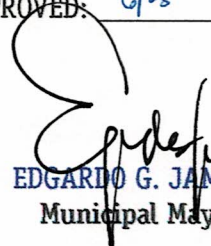
