ORDINANCE NO. 17, S. 1996

AN ORDINANCE PROVIDING FEE OF THE MAYOR'S PERMIT OF THE CABLE TELEVISION
NETWORK.

Be it ordained by the Sangguniang Bayan of Dumingag, Zamboanga del
Sur in session assembled that:

SECTION 1 - TITLE - This ordinance shall be called "AN ORDINANCE PROVID-
ing FEE OF THE MAYOR'S PERMIT OF THE CABLE TELEVISION
NETWORK."

SECTION 2 - MAYOR'S PERMIT - Since the Municipal Revenue Code states no
amount, the Mayor's Permit of the Cable Television Network
shall be fixed to TWO HUNDRED PESOS (P200.00).

SECTION 3 - MANDATORY PROVISIONS - This ordinance mandates the following:
3.1 Mayor's Permit Fee stated in this ordinance shall auto-
matically be incorporated in the Municipal Revenue Code.
3.2 Other Municipal Taxes and regulatory fees obligated by
the owners or operators of the Cable Television Network
are reflected in the Municipal Revenue Code.

SECTION 4 - REPEALING CLAUSE - All ordinances, resolutions, or laws of
local effect inconsistent with this ordinance are hereby
modified, superseded or repealed accordingly.

SECTION 5 - EFFECTIVITY - This ordinance shall take effect after the
approval of the Sangguniang Panlalawigan and after ten days
of its publication at the Municipal Bulletin Board.
