Ordinance No. 17, s. 2001

AN ORDINANCE FIXING TIME LIMITATION ON THE OPERATION OF VIDEOKE SING-ALONG AND VINTAGE JUKEBOX/KARAOKE AND PROVIDING PENALTIES FOR ANY VIOLATION THEREOF.

Be it ordained by the Sangguniang Bayan at Dumingag, Zamboanga del Sur.

SECTION 1. TITLE. This ordinance shall be called “An Ordinance fixing limitations on videoke Sing-Along Vintage Jukebox/Karaoke operating in this municipality of Dumingag.

SECTION 2. JUSTIFICATION. The sing-along, vintage jukebox and karaokes’ unlimited day and night operation has observably caused an alarming public disturbance and nuisance to the nearby occupants in the market area/place.

SECTION 3. PURPOSE. This ordinance aims to attain the following:

1. For peace and order sake.
2. To minimize the possible participation of young people/ youth.
3. To minimize vices
4. To allow a good night’s rest of the neighboring constituents.
5. To eliminate/minimize drug addiction.

SECTION 4. REGULATORY PROVISION. Sing-along, vintage jukebox and karaoke operation is hereby limited from 6:00 a.m. until 10:00 p.m. except special holidays: Town Fiesta celebration (March 17, 18 and 19) Christmas Eve and Christmas Day, New Year’ Eve and New Year.

SECTION 5. PENAL PROVISION. Any person, customer, owner/operator found guilty of violating this ordinance shall be penalized by a fine of:

SECTION 6. IMPLEMENTING BODY. The PNP, TANOD/BANTAY BAYAN/CVO and the Armed Forces of the Philippines shall be the implementing body of this ordinance.

SECTION 7. SEPARABILITY CLAUSE. Any part or provision of this ordinance which shall be held unconstitutional or invalid, other parts or provisions not affected hereby shall continue to be in full force and effect.

SECTION 8. REPEALING CLAUSE. Any resolution or ordinance inconsistent herewith is hereby modified, repealed or superseded accordingly.

SECTION 9. EFFECTIVITY CLAUSE. This ordinance shall take effect immediately upon approval.
