Municipal Ordinance No. 17, s. 2015

AN ORDINANCE CREATING TWO (2) POSITIONS OF DRIVER I (SG-3) IN THE OFFICE OF THE MUNICIPAL ENGINEERING AND BOOKBINDER IV (SG-10) AND MUNICIPAL AGRICULTURIST II (SG-15) IN THE OFFICE OF THE MUNICIPAL AGRICULTURE IN THIS MUNICIPALITY AND PROVIDING FUNDS THEREFOR.

Be it enacted by the Sangguniang Bayan Members of Dumingag, Zamboanga del Sur in session assembled that:

Section 1. TITLE.

This ordinance shall be called "An ordinance creating two (2) positions of Driver I (SG-3) in the Office of the Municipal Engineering and Bookbinder IV (SG-10) and Municipal Agriculturist II (SG-15) in the Office of the Municipal Agriculture in this municipality and providing funds therefor."

Section 2. CREATION.

This hereby created position shall be included in the plantilla of personnel of the Local Government of Dumingag, Zamboanga del Sur.

Section 3. APPROPRIATION.

The Municipal Budget Office shall prepare corresponding budget to cover outlay for the salaries and other emulations due to the creation of positions as provided for in Section 2. Therefore as well as mandatory and statutory obligation to be shouldered by the Municipal Government which shall be reflected every year in the executive annual budget.

Section 4. SEPARABILITY CLAUSE.

Any section or provision in this ordinance maybe declared unlawful or invalid the remainder of such declarations shall remain to be in full force and effect.

Section . EFFECTIVITY CLAUSE.

This ordinance shall take effect after the approval of the Sangguniang Panlalawigan and after fifteen (15) days from the date copy hereof is posted in the bulletin board in the entrance of the Municipal Hall and at least two (2) other conspicuous places in the Poblacion.

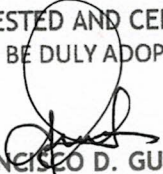

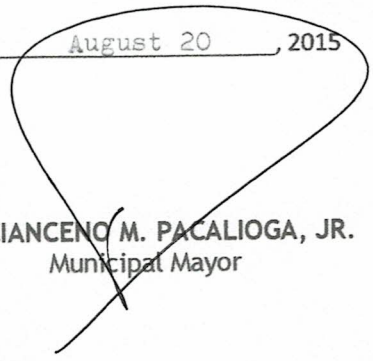
