**AN ORDINANCE IMPOSING RATE FOR "TRAVELLING SOUND SYSTEM"
OPERATING IN THIS MUNICIPALITY AND PROVINCE.**

Be it ordained by the Sangguniang Bayan of Dumingag, Zamboanga del Sur, in session assembled that:

SECTION 1. TITLE. This ordinance shall be known as **"An Ordinance imposing rate for Travelling Sound System operating in this municipality, province of Zamboanga del Sur."**

SECTION 2. TAX ON BUSINESS. There shall be imposed a fixed tax on business to operators or owners of Travelling Sound System, an amount shall be collected specifically for;

- Travelling sound system residents of Dumingag or in a barangay within the municipality will be taxed P500.00 per year.
- Travelling sound system owners/operators residing outside the municipality will be taxed P100/show or every time they are hired in this municipality : Poblacion or barangays.

SECTION 3. IMPLEMENTING RULES AND REGULATIONS. The Municipal Mayor through the recommendation of the Municipal Treasurer shall formulate implementing guidelines for proper implementation of this ordinance.

SECTION 4. SEPARABILITY CLAUSE. Any section or provision of this ordinance which may be declared unlawful or invalid, the remainder of such declaration shall remain to be in full force and effect.

SECTION 5. EFFECTIVITY CLAUSE. This ordinance shall take effect after the review by the Sangguniang Panlalawigan.
