Ordinance No. 19 s. 1999

AN ORDINANCE ORDAINING THE CODIFICATION OF THE GENERAL ORDINANCES OF THE MUNICIPALITY OF DUMINGAG, ZAMBOANGA DEL SUR.

Be it ordained by the Sangguniang Bayan of Dumingag, Zamboanga del Sur in session assembled that:

SECTION 1. TITLE. This code shall be known as the Code of General Ordinances of Dumingag, Zamboanga del Sur.

SECTION 2. RELATION TO PRIOR ORDINANCES. The provision of this code which are substantially the same as existing ordinances relating to the same subject matter shall be construed as restatement and not as new enactment. (The reason for this is to qualify that existing rights under former ordinances may not be prejudiced and that existing contracts may not be impaired).

SECTION 3. EXISTING RIGHTS. No action or proceeding commence before this code takes effect and no right accrued, is affected by this code. All procedure after the effectivity of this code shall conform to the provisions of this code unless specifically provided.

SECTION 4. REFERENCE TO THIS CODE. Whenever reference is made to any provisions of this code, the reference applies to all amendments and additions now or hereafter made.

SECTION 5. COVERAGE. The definition of terms and phrases embodied in the chapter shall govern the interdependence and meaning of these terms and phrases as found in the specific sections and chapters.

SECTION 6. TECHNICAL TERMS DEFINED. Definitions of particular terms are embodied herein to easier correlation and reference.

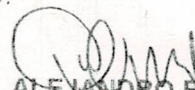
SECTION 7. SEPARABILITY CLAUSE. Should any provision, section, or part of this code be declared unconstitutional or invalid by a competent court, this shall not affect the other sections or part of this code.

SECTION 8. REPEALING CLAUSE. All ordinances, rules and regulations which are inconsistent with any provision of this code are repealed or modified accordingly.

SECTION 9. DATE OF EFFECTIVITY. This code shall take effect upon approval by the Municipal Mayor and becomes effective as a new enactment for the local government.

Enacted this 8th day of November, 1999 of the Sangguniang Bayan of Dumingag, Zamboanga del Sur as introduced by Hon. Juliet E. Rojas during its regular session held at the municipal session hall.

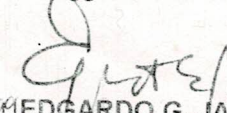
