Ordinance No. 19, s. 2002

"AN ORDINANCE REQUIRING ALL PET DOG OWNERS TO SUBMIT FOR COMPULSORY VACCINATION THEIR PET DOGS WITH ANTI-RABIES VACCINE AND IMPOSING PENALTIES FOR VIOLATION THEREOF."

Section 1. TITLE - "Anti-Rabies Ordinance of Dumingag, Zamboanga del Sur."

Section 2. SCOPE. This ordinance shall apply to all pet dog owners within the municipality of Dumingag, Zamboanga del Sur.

Section 3. PURPOSE. The purpose of this ordinance is to minimize, if not totally eradicate, rabies cases in this municipality.

Section 4. DEFINITION OF TERMS

1. *Rabies* - an acute, infectious, viral disease transmitted by the bite of an infected animal.
2. *Anti-Rabies Vaccine* - a kind of medicine for the prevention of rabies.
3. *Vaccination* - is an act of treatment/campaign/activity for rabies prevention.

Section 5. MANDATORY PROVISIONS

1. Pet dogs owners are obliged/mandated to vaccinate their pet dogs regularly at least once a year with anti-rabies vaccine.
2. All pet dog owners are mandated to submit their pet dogs to the Municipal Agriculture and Health office any time these offices will conduct a mass vaccination on anti-rabies.
3. All pet dog owners shall shoulder the expenses on anti-rabies vaccination in case these offices concerned are out of stock/budget.
4. The Municipal Agriculture and Health Office shall register the number of pet dogs and the name of pet dog owners to facilitate the vaccination activity.

Section 6. IMPLEMENTING AGENCY - The office of the Municipal Mayor through the Municipal Agriculture, Health Office, the Dumingag Philippine National Police and the personnel authorized by the Municipal Mayor are mandated to enforce strictly this ordinance.

Section 7. PENAL CLAUSE - Any person found violating this ordinance shall be fined:

1. P200.00 - 1st offense
2. P1,000.00 - or 30 days imprisonment or both for 2nd and subsequent offenses.

Section 8. SEPARABILITY CLAUSE - If for any reason, any section or provision of this ordinance shall be declared unconstitutional or invalid, the other section of provisions hereof which are not affected thereby shall continue in full force and effect.

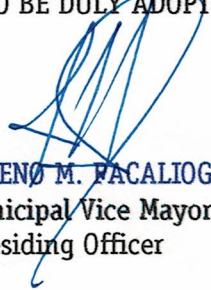
Section 9. EFFECTIVITY AND PUBLICATION CLAUSE - This ordinance shall take effect after the approval of the Sangguniang Panlalawigan and after fifteen (15) days from the date copy hereof is posted in the Bulletin Board at the entrance of the Municipal hall and in at least two (2) other conspicuous places in the Poblacion, announcement in the Local Cable TV, and FM stations and further, published in a local newspaper of general circulation once a week for three consecutive weeks, informing the constituents of the provisions and date of the effectivity thereof.

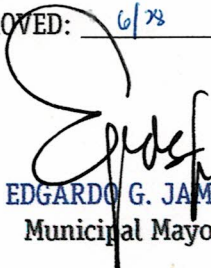
