Ordinance No. 2, s. 2005

ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 3, S. 1995 ENTITLED, "AN ORDINANCE FIXING A PARKING FEE OF VARIOUS TRANSPORT UNITS/FACILITIES IN DUMINGAG, ZAMBOANGA DEL SUR.

Be it ordained by the Sangguniang Bayan of Dumingag, Zamboanga del Sur in Session Assembled that:

Section 1. TITLE. "An Ordinance Amending Municipal Ordinance No. 3, s. 1995 Entitled, "An Ordinance Fixing a Parking Fee of Various Transport Units/Facilities in Dumingag, Zamboanga del Sur".

Section 2. FEES. Collection of daily parking fees at the LGU parking areas shall be as follows:

Section 3. PENAL PROVISION. Any driver or person who violated this ordinance shall be penalized accordingly on the following offenses:

- 1<sup>st</sup> Offense – A fine of P100.00 or an imprisonment of two days or both at the discretion of the court.
- 2<sup>nd</sup> Offense – A fine of P200.00 or an imprisonment of three days or both at the discretion of the court.
- 3<sup>rd</sup> and succeeding offenses – A fine of P300.00 or an imprisonment of five days or both at the discretion of the court.

Section 4. REPEALING CLAUSE. All resolutions, ordinances, or laws of local effect inconsistent with this ordinance are hereby modified, superseded, or repealed accordingly.

Section 5. EFFECTIVITY AND PUBLICATION CLAUSE. This ordinance shall take effect after the approval of the Sangguniang Panlalawigan and after fifteen (15) days from the date copy hereof is posted in the bulletin board at the entrance of the municipal hall and in at least two (2) other conspicuous places in the Poblacion, published in a local newspaper of general circulation once a week for three consecutive weeks or posted in the municipal hall of all municipalities within the province of Zamboanga del Sur
