Ordinance No. 2, s. 2009

ORDINANCE FIXING RATES FOR THE RENTAL OF THE LGU VEHICLES OF THE MUNICIPALITY OF DUMINGAG, ZAMBOANGA DEL SUR.

Be it ordained by the Sangguniang Bayan of Dumingag, Zamboanga del Sur in session assembled that:

SECTION 1. This ordinance shall be called "Ordinance Fixing Rates for the Rental of the LGU Vehicles of the Municipality of Dumingag, Zamboanga del Sur."

SECTION 2. There shall be imposed rental for the use of LGU Vehicles in the following breakdown:

2.1. Rental Rate Per Day

2.1.a Government Use

<u>VEHICLE</u>	<u>Rate per Day</u>
Military Dumptruck	P1,000.00 excluding fuel & oil
Military/Service Jeep	P 500.00 excluding fuel & oil
LGU Owned Jeepney	P1,500.00 excluding fuel & oil

2.1.b Private use

<u>VEHICLE</u>	<u>Rate per Day</u>
Military Dumptruck	P2,000.00 excluding fuel & oil
Military/Service Jeep	P 1,000.00 excluding fuel & oil
LGU Owned Jeepney	P3,000.00 excluding fuel & oil

SECTION 3. IMPLEMENTING RULES AND REGULATIONS. The Municipal Mayor through the recommendation of the Municipal Treasurer shall formulate an implementing guidelines for proper implementation of this ordinance.

SECTION 4. SEPARABILITY CLAUSE. If, for any reason, a portion of this ordinance is declared null and void, the rest of the portion thereof not affected by such declaration shall be in effect and subsisting.

SECTION 5. EFFECTIVITY CLAUSE. This ordinance shall take effect after the approval of the Sangguniang Panlalawigan and after fifteen (15) days from the date copy hereof is posted in the Bulletin Board at the entrance of the Municipal hall and in at least two (2) other conspicuous places in the Poblacion and published in a local newspaper of general circulation once a week for three consecutive weeks, informing the constituents of the provisions and date of the effectivity thereof.
