ORDINANCE NO. 20, S. 1996

AN ORDINANCE REGULATING MAHJONG AND BILLIARD GAMES: TOTAL PROHIBITION FOR MINORS, PARTIAL PROHIBITION FOR STUDENTS AND IMPOSING PENALTIES FOR VIOLATION THEREOF:

Be it ordained by the Sanggunian Bayan in session assembled, that:

- SECTION 1 - This ordinance shall be entitled: "AN ORDINANCE REGULATING MAHJONG/BILLIARD GAMES: TOTAL PROHIBITION FOR MINORS, PARTIAL PROHIBITION FOR STUDENTS AND IMPOSING PENALTIES FOR VIOLATION THEREOF.
- SECTION 2 - There shall be only two Mahjong and two Billiard stations allowed to operate in every barangay daily, to close shop up to 12:00 P.M.(Midnight)only;
- SECTION 3 - Total ban shall be imposed upon all minors: 15 years old and below, students are prohibited during class only. Any minor or student caught playing shall be reprimanded for the first and second offense to be followed by detention at the prison cell for rehab and education purposes.
- SECTION 4 - Any Mahjong/BILLIARD OWNER/OPERATOR caught tolerating minors/students in the game shall be fined:

| Third Continuous offense | - | closure of establishment or upon discretion of the court. |
- SECTION 5 - The BNP and all Barangay Officials shall be the frontline implementors of this ordinance.
- SECTION 6 - All resolutions, ordinances, laws of local effect inconsistent herewith are modified, superseded or repealed accordingly.
- SECTION 7 - This ordinance shall take effect after review/approval by the Sanggunian Panlalawigan and after 15 days posting at the Municipal session Hall and other conspicuous places.
