Ordinance No. 23, s. 2001

AN ORDINANCE DECLARING THE VICINITY, COMPOUND AND PREMISES OF THE MUNICIPAL HALL OF DUMINGAG, ZAMBOANGA DEL SUR AS "SMOKE-FREE ZONE OR AREA."

WHEREAS, smoking inside government offices, hospitals, clinics and public conveyances is prohibited pursuant to Municipal Ordinance No. 4, s. 1997 as amended;

WHEREAS, in support of said Ordinance;

Be it ordained by the Sangguniang Bayan that:

Section 1. DECLARATION.

(a) The vicinity, compound and premises of the municipal hall of Dumingag, Zamboanga del Sur are hereby declared "SMOKE-FREE ZONE OR AREA."

(b). There shall be placed a signboard " SMOKE-FREE COMPOUND" at the entrances (gates) of the municipal compound.

Section 2. DEFINITION.

"VICINITY, COMPOUND AND PREMISES OF THE MUNICIPAL HALL" - shall mean the enclosed area or place located within and inside the perimeter of the municipal hall or building of Dumingag, Zamboanga del Sur.

Section 3. ENFORCEMENT BODY. The Office of the Municipal Mayor in coordination with the Head of Offices, PNP and Municipal Security Guards.

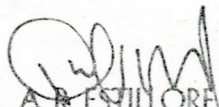
Section 4. PENALTY. Any person found smoking inside the vicinity, compound and premises of the municipal hall or building of Dumingag, Zamboanga del Sur shall be punished by a fine of not less than FIVE HUNDRED (P500.00) PESOS or imprisonment of not less than 30 days but not more than six (6) months or both fine and imprisonment at the discretion of the court.

Section 5. REPEALING CLAUSE. All ordinances, rules and regulations or parts thereof where provisions are in conflict with or contrary to the provisions of this ordinance are hereby repealed, amended or modified accordingly.

Section 6. EFFECTIVITY. This ordinance shall take effect upon its approval.
