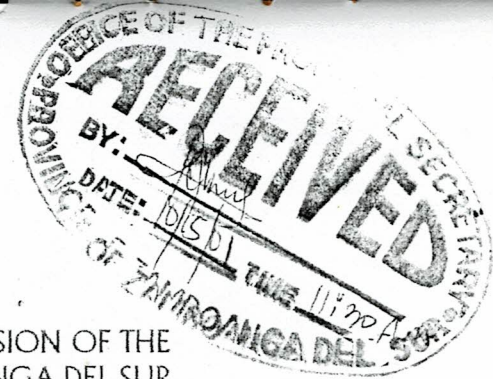

Ordinance No. 26, s. 2001

AN ORDINANCE ESTABLISHING A REFUGE CENTER FOR WOMEN AND CHILDREN OF THE MUNICIPALITY OF DUMINGAG, ZAMBOANGA DEL SUR AND PROVIDING FUNDS THEREOF.

WHEREAS, there is a need of providing a temporary refuge for battered women and abused children in our municipality in support of our move toward protecting and rehabilitating women and children from violence and abuses;

WHEREAS, there is no existing refuge center for this particular purpose;

WHEREAS, the provision of a refuge center for women and children in this municipality is indispensable and must be prioritized;

NOW, THEREFORE, be it ordained by the Sangguniang Bayan of Dumingag, Zamboanga del Sur in session assembled that:

Section 1. TITLE - "An Ordinance Establishing a Refuge Center for Women and Children of the Municipality of Dumingag, Zamboanga del Sur and providing funds thereof."

Section 2. PURPOSES - This ordinance aims to provide a temporary refuge for women and children who are victims of violence, discrimination and abuses.

Section 3. MANDATORY PROVISIONS - This ordinance mandates the following provisions:

1. There shall be provided refuge center for women and children in the Municipality of Dumingag, Zamboanga del Sur.
2. The center shall be manned by a qualified personnel purposely hired to manage/supervise the operation of the center.
3. There shall be allocated an amount of THREE HUNDRED THOUSAND (P300,000.00) PESOS for the construction of said center chargeable against the 20% Development Fund to be incorporated to the next year's annual budget allocation.
4. Said refuge center shall be provided with facilities appropriate for its operation.

Section 4. IMPLEMENTING RULES AND REGULATIONS. The Office of the Municipal Mayor is mandated to implement this ordinance. The Office of the Municipal Social Welfare and Development shall be the lead agency delegated to manage the center in coordination with the Police Officer Incharge of the Women's Desk.

Section 5. EFFECTIVITY. This ordinance shall take effect upon approval.
