Ordinance No. 27, s. 2001

AN ORDINANCE BANNING THE PLAYING/USING OR SELLING/DISPLAYING OF TOYS RELATED TO VIOLENCE AND WAR WITHIN THE MUNICIPALITY OF DUMINGAG, ZAMBOANGA DEL SUR AND PROVIDING PENALTY THEREOF.

Be it enacted by the Sangguniang Bayan in session assembled that:

Section 1. TITLE: This ordinance shall be called "An Ordinance Banning the Playing/Using or Selling/Displaying of Toys Related to Violence and War and Providing Penalty Thereof."

Section 2. LEGAL AUTHORITY. This measure is pursuant to Presidential Decree 603 (Child and Youth Welfare Code) and Section 2 of RA 7160 known as Local Government Code of 1991 empowering Sangguniang Bayan to enact measures to prevent and suppress lawlessness, disorder, riot, violence, rebellion or sedition and impose penalties for the violation of said ordinance.

Section 3. PURPOSE. The purpose of this ordinance is to protect children from early exposure to hostilities and violence with the use of toys related to weapons of war.

Section 4. REGULATORY PROVISIONS.

- 4.1. No person is allowed to play or use toys related to weapons of war, conflict, hostility or violence within the municipality of Dumingag.
- 4.2. No business owner/operator/establishment is allowed to sell or display toys related to weapons of war, conflict, hostility or violence.
- 4.3. No person is allowed to carry/transport/include in his possession any toys of the same category as in 4.2.
- 4.4. Toys shall be confiscated and destroyed.

Section 5. PENAL PROVISION. Any person or parent of the minor violating this ordinance shall be meted the following penalties:

- 5.1. First Offense - P 100.00
- 5.2. Second Offense - P 200.00
- 5.3. Third and Subsequent Offenses - P 500.00 or an imprisonment of not more than 3 days or both upon the discretion of the court.

Section 6. ENFORCEMENT PROVISION. The Office of the Municipal Mayor in coordination with the Police Officer shall be the frontline implementors of this ordinance. Copies of this ordinance shall be furnished all commercial establishments and educational institutions at all levels be they public or private, as reference. Other agencies/instrumentalities shall, in accordance with their own functions and jurisdiction, be mandated to implement this ordinance.

Section 7. REPEALING CLAUSE. Any existing ordinance counter with this ordinance is hereby repealed.

Section 8. EFFECTIVITY CLAUSE. This ordinance shall take effect upon approval.
