Ordinance No. 3, s. 2002

AN ORDINANCE PROHIBITING THE DISPLAY/POSTING OF PORNOGRAPHIC MATERIAL ON PUBLIC UTILITY VEHICLES IN THE MUNICIPALITY OF DUMINGAG AND IMPOSING PENALTY FOR VIOLATION THEREOF.

WHEREAS, public utility operators/drivers/owners are posting and displaying pornographic and/or lewd materials on their vehicles particularly on buses and jeepneys ;

WHEREAS, this practice not only violates public morals but would also compromise and endanger public safety;

THEREFORE, be it ordained by the Sangguniang Bayan in session assembled that:

Section 1. TITLE. The title of this ordinance shall be called "Anti-Posting Pornographic Materials on Public Utility Vehicles Law of Dumingag."

Section 2. LEGAL AUTHORITY AND PURPOSE. This ordinance is enacted pursuant to R.A. No. 4136 otherwise known as the "Land Transportation and Traffic Code." With the aim of strictly prohibiting the posting and displaying of indecent materials or if posted immediate removal of the same is required.

Section 3. DEFINITION OF TERMS: As used in this ordinance;

*Pornographic display of materials* - the depiction of erotic behavior designed primarily to cause sexual excitement.

Section 4. LEGAL PROVISIONS.

1. No vehicle driver/operator/owner shall be allowed to post/display any photographic materials to any public vehicles.
2. No owner/operator/ shall allow any person to post/display any pornographic materials to their respective public vehicles

Section 5. PENAL PROVISIONS. Any person who fails to comply with the provision of this ordinance shall be meted the following penalties.

5.1 Any operator/driver who willfully violates the provision of this ordinance shall be for the

Section 6. REPEALING CLAUSE. All ordinances, rules and regulation, or sorts thereof, whose provisions are in conflict with, or contrary to the provisions of this ordinance are hereby repealed, amended or modified accordingly.

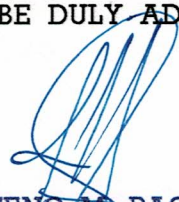
Section 7. EFFECTIVITY CLAUSE. This ordinance shall take effect after the approval of the Sangguniang Panlalawigan and after fifteen (15) days from the date copy hereof is posted in the Bulletin Board at the entrance of the Municipal hall and in at least two (2) other conspicuous places in the Poblacion, announcement in the Local Cable TV, and FM stations and further, published in a local newspaper of general circulation once a week for three consecutive weeks, informing the constituents of the provisions and date of the effectivity thereof.
