ORDINANCE NO. 3, s. 2004

**AN AMENDATORY ORDINANCE FIXING RATES FOR THE RENTAL OF THE LGU
HEAVY EQUIPMENT OF THE MUNICIPALITY OF DUMINGAG, ZAMBOANGA DEL SUR.**

Be it ordained by the Sangguniang Bayan in session assembled that :

SECTION 1. This ordinance shall be called "An Amendatory Ordinance Fixing Rates for the Rental of the LGU Heavy Equipment of the Municipality of Dumingag, Zamboanga del Sur."

SECTION 2. There shall be imposed rental for the use of heavy equipments in the following

2.1. Rental Rate Per Day

2.2. For Ten (10) Wheeler Dumptruck - Loaded with Sand and Gravel. An amount of One Hundred Pesos (P500.00) per load shall be charged for the first 5 kilometres plus Fifty Pesos (P50.00) per kilometre for every succeeding kilometre.

2.3. For Ten (10) Wheeler Dumptruck - Loaded with Timber. An amount of Eight Hundred Pesos (P800.00) per load shall be charged for the first 5 kilometres plus Fifty Pesos (P50.00) per kilometre for every succeeding kilometre.

2.4. For Six (6) Wheeler Dumptruck - Loaded with Sand and Gravel. An amount of Three Hundred Pesos (P300.00) per load shall be charged for the first 5 kilometres plus Fifty Pesos (P50.00) per kilometre for every succeeding kilometre.

2.5. For Six (6) Wheeler Dumptruck - Loaded with Timber. An amount of Five hundred Pesos (P500.00) per load shall be charged for the first 5 kilometres plus Fifty Pesos (P50.00) per kilometre for every succeeding kilometre.

SECTION 3. IMPLEMENTING RULES AND REGULATIONS. The Municipal Mayor through the recommendation of the Municipal Treasurer shall formulate an implementing guidelines for proper implementation of this ordinance.

SECTION 4. SEPARABILITY CLAUSE. If, for any reason, a portion of this ordinance is declared null and void, the rest of the portion thereof not affected by such declaration shall be in effect and subsisting.

SECTION 5. EFFECTIVITY CLAUSE. This ordinance shall take effect after the approval of the Sangguniang Panlalawigan and after fifteen (15) days from the date copy hereof is posted in the Bulletin Board at the entrance of the Municipal hall and in at least two (2) other conspicuous places in the Poblacion and published in a local newspaper of general circulation once a week for three consecutive weeks, informing the constituents of the provisions and date of the effectivity thereof.
