ORDINANCE NO. 3, s. 2011

AN ORDINANCE AMENDING THE REVISED REVENUE CODE (MUNICIPAL ORD. #1, S. 2008) OF THE MUNICIPALITY OF DUMINGAG, ZAMBOANGA DEL SUR, SO AS TO IMPOSE NEW RATES OF FEES AND CHARGES THEREUNDER SUBJECT TO ALL LEGAL AND EXISTING RULES AND REGULATIONS.

Be it ordained by the Sangguniang Bayan in session assembled that:

Section 1. TITLE.

This Ordinance shall be called "An Ordinance Amending the Revised Revenue Code (Municipal Ord. #1, s. 2008) of the Municipality Of Dumingag, Zamboanga Del Sur, so as to impose new rates of fees and charges thereunder subject to all legal and existing rules and regulations."

Section 2. PURPOSE.

The Local Government Unit, with the power vested upon it to prescribe and update rates, shall impose new rates of fees and charges in some items of the Revised Revenue Code deemed practical to commensurate to the cost of regulation, monitoring and surveillance.

Section 3. AMENDMENT.

Rates of fees and charges in Section III.b.4 and Section IV.A. shall be amended as follows:

Items		Old rate	New rate
Mahjong	Mayor's Permit	P 300.00	P 1,000.00
Mineral ores, coal dolomiths, or limestone	Permit fee to transport	5.00/truck load	30.00/truck load
Sand and gravel, field stones, rocks and other road materials	Fee	30.00/cu.m.	P60.00/cu.m.

Section 4. REPEALING CLAUSE.

Any part of provisions of this Ordinance in conflict with or contrary to the existing ordinances are hereby repealed, amended or modified accordingly.

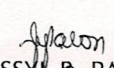
Section 5. EFFECTIVITY CLAUSE.

This ordinance shall take effect after the approval of the Sangguniang Panlalawigan and after 15 days a copy hereof is posted in the bulletin board in the municipal hall and two other conspicuous places and published in a newspaper of general circulation.
