Ordinance No. 3, s. 2013

AN ORDINANCE CREATING THE POSITIONS OF 2 ADMINISTRATIVE AIDE I IN THE OFFICE OF THE MUNICIPAL INDIGENOUS PEOPLES AFFAIRS, 1 ADMINISTRATIVE AIDE IN THE OFFICE OF THE MUNICIPAL PLANNING DEVELOPMENT OFFICE, 1 ADMINISTRATIVE AIDE IN THE OFFICE OF THE MEDO AND PROVIDING FUNDS THEREFOR.

Be it ordained by the Sangguniang Bayan of Dumingag, Zamboanga del Sur, in session assembled, that:

SECTION 1. TITLE.

This ordinance shall be called "AN ORDINANCE CREATING THE POSITIONS OF 2 ADMINISTRATIVE AIDE I IN THE OFFICE OF THE MUNICIPAL INDIGENOUS PEOPLES AFFAIRS OFFICE, 1 ADMINISTRATIVE AIDE IN THE OFFICE OF THE MUNICIPAL PLANNING DEVELOPMENT OFFICE, 1 ADMINISTRATIVE AIDE IN THE OFFICE OF THE MUNICIPAL ECONOMIC DEVELOPMENT OFFICE RESPECTIVELY AND PROVIDING FUNDS THEREFOR."

SECTION 2. CREATION.

There is hereby created positions to be included in the plantilla of personnel of the local government unit of Dumingag, Zamboanga del Sur.

SECTION 3. APPROPRIATION.

For this purpose, the Municipal Budget Officer shall prepare corresponding supplemental budget to cover outlay for the salaries and for other emoluments due for the created positions as provided for in section 2 thereof as well as mandatory and statutory obligations to be shouldered by the municipal government, which shall be reflected every year in the executive budget.

SECTION 4. SEPARABILITY CLAUSE.

Any section or provision of this ordinance which maybe declared unlawful or invalid, the remainder of such declarations, shall remain to be in full force and effect.

SECTION 5. EFFECTIVITY.

This ordinance shall take effect after the approval of the Sangguniang Panlalawigan and after 15 days a copy hereof is posted in the bulletin board in the municipal hall and two other conspicuous places.
