Ordinance No. 37, s. 2001

AN ORDINANCE PROHIBITING ILLEGAL TAPPING OF CABLE WIRE WITHIN THE MUNICIPALITY OF DUMINGAG.

Be it enacted by the Sangguniang Bayan in session, that:

Section 1. TITLE. This ordinance shall be called Anti-Cable Wire Tapping Law of Dumingag.

Section 2. PURPOSE. This ordinance aims to promulgate a new local measure that will protect the welfare of the cable wire proprietors/operators from illegal wire tapping.

Section 3. DEFINITION OF TERMS.

- 3.1. Illegal wire tapping. It is the act of injecting, tying, placing/hanging, magnetic materials, into or near the cable wire with the purpose of tapping or generating cable television with no obligation of paying the monthly cable bill.

Section 4. REGULATORY PROVISIONS. There shall be adopted regulatory Provisions to arrest the progress of illegal cable wire tapping in the municipality of Dumingag.

- 4.1. No person is allowed to inject any kind of iron/metallic pointed object into the cable wire such as but not limited to needles, pins, nails, etc.
4.2. Any person is prohibited to allow any magnetic material to touch or tie/wind/fasten around the mainline or cable wire.
4.3. Any person is prohibited to place/hang magnetic materials within the periphery of less than one foot of the mainline or cable wire.

Section 5. PENAL PROVISIONS. Any person found violating this ordinance shall be meted any of the following penalties:

- 5.1 First offense - P500.00
5.2 Second offense - P1,000.00
5.3 Third & subsequent offenses - P1,500.00

Section 6. SEPARABILITY CLAUSE. If any section or provision of this ordinance may be declared unlawful or invalid, the rest of the sections not affected therein shall remain to be in full force and effect.

Section 7. EFFECTIVITY CLAUSE. This ordinance shall take effect after review and approval of the Sangguniang Panlalawigan and after three weeks from the date copy hereof is posted in the Bulletin Board at the entrance of the Municipal Hall and in at least two other conspicuous places in the Poblacion and further, announcement in the local Cable TV, informing the constituents of the provisions and date of effectivity thereof.
