ORDINANCE NO. 4, S. 1997

" AN ORDINANCE PROHIBITING SMOKING INSIDE GOVERNMENT/PRIVATE OFFICES, SCHOOLS, HOSPITALS/CLINICS, GYMNASIUMS, DANCING HALLS AND PUBLIC CONVEYANCES, BY PROVIDING AND DESIGNATING SMOKING AREAS, AND IMPOSING PENALTIES FOR VIOLATION THEREOF. " (Kag. Anggaos & Pacalioga)

Be it enacted by the Sangguniang Bayan of Dumingag, Zamboanga del Sur in session assembled:

SECTION 1. PURPOSE - As per finding of the medicine specialists, smoking is dangerous to the health and it will cause lung cancer, ulcer and other ailments. There are smokers who die because of such diseases. Therefore, the purpose of enactment of this ordinance is to protect the health of the general public (people) from the bad effects of the smoke from tobaccos.

SECTION 2. DEFINITION OF TERMS - As used oin this ordinance, the following terms shall mean:

1. Office - a building, room or series of rooms in which the affairs of a branch of a government or private firm is carried on.
2. School - a place or institution for teaching and learning or establishment for education.
3. Prohibiting - limiting, forbidding
4. Hospital/Clinic - a place or institution where the ill or the injured receive medical, surgical, dental or psychiatric treatment, nursing care, food and lodging, etc.
5. Gymnasium - a place where athletic and sports events and other forms of entertainment are shown.
6. Public Conveyances - vehicles used to transport the riding public on land.

7. Convention Center - a place wherein mass gathering for such occasions as conventions, meetings are held.

8. Smoking - drawing of smoke from the tobacco into the mouth or lungs and usually blown it again and or carrying a lighted cigar, cigarette or tobacco in a pipe.

SECTION 3. REGULATORY PROVISIONS - This ordinance provides the following provisions:

3. a No person shall smoke inside government or private offices, schools, hospitals/clinics, gymnasiums, dancing halls, barangay or municipal halls, session halls, convention centers and in all public conveyances, except in designated smoking areas.

3. b The Head or Chief of the office may designate smoking areas outside the office.

SECTION 4. PENAL PROVISIONS - Any person found guilty of violating any section of this ordinance shall be fined of Two Hundred Pesos (P200.00) for his/her first offense and Five Hundred (P500.00) pesos for the second offense or suffer an imprisonment of not less than five (5) days but not more than ten (10) days or both at the discretion of the court.

SECTION 5. ENFORCEMENT - The Philippine National Police (PNP), Barangay Captains and all Heads of Officers within the municipality of Dumagag are hereby enjoined to enforce this ordinance.

SECTION 6. REPEALING CLAUSE - Any existing resolutions, ordinances or parts thereof which are inconsistent with this ordinance are hereby modified, repealed or superseded accordingly.

SECTION 7. SEPARABILITY CLAUSE - Any provision or part of this ordinance may be declared invalid or unconstitutional, other parts or provisions not affected thereby shall continue in full force and effect.

SECTION 8. EFFECTIVITY - This ordinance shall take effect after the review and approval by the Sangguniang Panlalawigan.

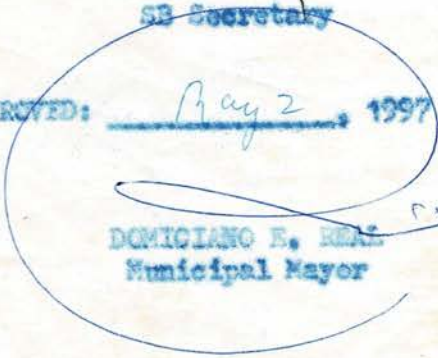

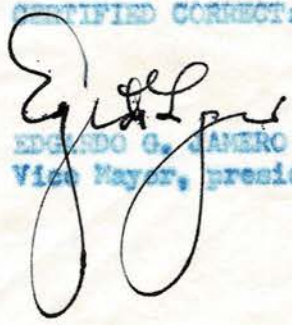
