Ordinance No. 4, s. 2000

AN ORDINANCE PROVIDING INSURANCE COVERAGE TO BANTAY BAYAN MEMBERS IN EVERY BARANGAY WITHIN THE MUNICIPALITY, PRESCRIBING RULES AND MECHANICS FOR ITS EFFECTIVE IMPLEMENTATION AND APPROPRIATING FUNDS THEREFOR.

BE IT ENACTED BY THE SANGGUNIANG BAYAN OF DUMINGAG, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. TITLE - This ordinance shall be known and cited as the "Dumingag Bantay Bayan Insurance Coverage Law of 2000".

Section 2. INTRODUCTORY PROVISIONS - (a) Pursuant to Executive Order No. 309, as amended by E.O. No. 317 and E.O. No. 320, the chairman of the Municipal Peace and Order Council (MPOC) which is the Municipal Mayor shall be responsible for the proper management and supervision of the Bantay Bayan (BB) in coordination with other appropriate government entities.

(b) Pursuant to (viii), (1), Section 447 of RA No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Bayan will provide insurance coverage to service units when the finances of the municipal government allow said coverage.

(c) Per resolution No. 108, s. 1999, TWO HUNDRED THOUSAND PESOS (P200,000) was appropriated for Life Insurance Coverage of Bantay Bayan Members which was incorporated in the Annual for CY 2000, particularly at the TWENTY PERCENT (20%) EDF under Appropriation Ordinance No. 42, s. 1999.

Section 3. GENERAL PROVISIONS - (a) The Municipal Mayor through the Municipal Peace and Order Council (MPOC) shall determine the number of Bantay Bayan Members in every barangay, as recommended by the Sangguniang Barangay concerned, with the final lists of names to be submitted to the Sangguniang Bayan, as basis for Insurance Coverage.

(b) The Office of the Municipal Mayor shall issue an ID Card to every bonafide Member of the Bantay Bayan which signatories shall be the Municipal Mayor (MPOC Chairman), Municipal Government Operations Officer (Head, MPOC Secretariat) and the chairman on the committee on Peace and Order of the Sangguniang Bayan. The said ID Cards shall be laminated with pin and be issued free of charge, which the expenses that may be incurred in the

production thereof, shall be shouldered by the municipal government chargeable to the issuing office or any allocation for the purpose.

Section 4. PURPOSES - This Ordinance aims to compensate the service of the Bantay Bayan Members even only to Life Insurance Coverage and to support the management and supervision of the MPOC Chairman to the Bantay Bayan towards better public service in the maintenance of peace and order.

Section 5. SCOPE AND APPLICATION - This Ordinance shall apply to all bonafide Members of Bantay Bayan in every barangay of the Municipality of Dumingag, Province of Zamboanga del Sur. For purposes of this Ordinance, any organization of CVO or Bantay Bayan in any barangay shall be integrated and be called "Bantay Bayan".

Section 6. REGULATORY PROVISIONS - There is hereby granted a Life Insurance Coverage by the Local Government Unit (LGU) of Dumingag, Zamboanga del Sur to all Bantay Bayan Members with rules and mechanics for its effective implementation, to wit:

(a) Any bonafide Member of Bantay Bayan or his beneficiary may claim and receive cash assistance/insurance benefits from the municipal government in any case, viz:

1. Physical Injury while on Duty (Cash Assistance)	-	P 5,000.00
2. Death Not on Duty but Bonafide Member (Burial Benefit)	-	P 5,000.00
3. Death On Duty (Burial Benefit)	-	P 5,000.00
4. Death On Duty (Public Service Benefit)	-	P10,000.00

(b) The Insurance Coverage of the Bantay Bayan Members will be claimed and received by the Member/Beneficiary from the municipal government, provided, however, that requirements are complied and submitted to the Office of the Municipal Mayor, to wit:

1. Punong Barangay Certification stating thereon the occurrence in nature of incident to include whether the Bantay Bayan concerned was on duty or not;
2. Medical Certification duly signed by the attending physician of the hospital being confined by the BB Member;
4. Death Certification from LCR Office (In case of death);
5. Application Form from the Office of the Municipal Mayor, duly filled in by the BB Member concerned or his beneficiary/claimant, recommended by the Punong Barangay concerned and approve by the Municipal Mayor;
6. SB Resolutions appropriating for such amount; and
7. Proper Voucher duly signed by all concerned for issuance of check to be withdrawn from the bank which funds for Insurance Coverage of Bantay Bayan is being deposited.

(c) The amount appropriated for Life Insurance Coverage of the Bantay Bayan Members must be deposited to the Official Bank of the municipal government which shall be withdrawn only for the purpose. After the close of each fiscal year, if the amount deposited for Bantay Bayan Insurance Coverage will not be consumed for the purpose, the remaining amount shall not be withdrawn for any LGU disbursement, waiting for another annual budgets. However, in the succeeding year where another annual budgets is available, the remaining amount of the preceding annual budget may be used for Bantay Bayan Members other than Life Insurance Coverage, as may be appropriated by the Sangguniang Bayan upon recommendation of the Municipal Mayor.

Section 7. APPROPRIATION - There is hereby appropriated an amount of TWO HUNDRED THOUSAND PESOS (P 200,000.00), as incorporated in the Annual Budget for CY 2000 under Appropriation Ordinance No. 42, s. 1999, particularly at the Twenty Percent (20%) EDF which must be reflected every year in the annual budget, to be prepared by the Municipal Planning and Development Coordinator (MPDC), purposely for Life Insurance Coverage of Bantay Bayan Members.

Section 8. ENFORCEMENT OFFICE - The Office of the Municipal Mayor shall enforce this Ordinance in order to carry properly the purposes therefore.

Section 9. PENAL PROVISION - Any official or employees who violates this Ordinance may be meted administrative sanctions.

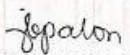
Section 10. SEPARABILITY CLAUSE - If any part or provision of this Ordinance may be declared invalid or unconstitutional, the remaining portion not affected by such declaration shall remain to be in full force and effect.

Section 11. REPEALING CLAUSE - Any provision resolution or ordinance inconsistent hereof is/are modified, repealed or superseded accordingly.

Section 12. EFFECTIVITY - This Ordinance shall take effect upon approval.

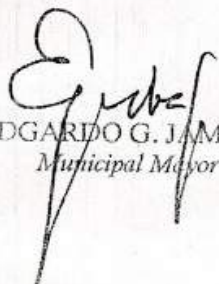
