Ordinance No. 4, s. 2006 - Disapproved

AN ORDINANCE PROVIDING PARTICULAR RULES AND REGULATIONS GOVERNING VEHICULAR TRAFFIC IN THE MUNICIPALITY OF DUMINGAG, ZAMBOANGA DEL SUR AND WITH CORRESPONDING PENALTIES FOR VIOLATION THEREOF.

Be it Ordained by the Sangguniang Bayan of Dumingag, Zamboanga del Sur in Session Assembled that:

Section 1. TITLE. This Ordinance shall be called as "An Ordinance Providing Particular Rules and Regulations Governing Vehicular Traffic in the Municipality of Dumingag, Zamboanga del Sur and with Corresponding Penalties for Violation Thereof".

Section 2. PURPOSE. This aims to prevent vehicular accidents caused by unlawful irresponsible and negligent acts of drivers.

Section 3. TRAFFIC VIOLATIONS AND IMPROPER USE OF MOTOR VEHICLES. The following acts or omissions in the operation of any motor vehicle and the use of thoroughfares are declared traffic violations with corresponding penalties, to wit:

1. Driving without license	P200.00
2. Failure to carry Driver's License	50.00
3. Driving while under the influence of liquor prohibited drugs	500.00
4. Driving without upper shirt	100.00
5. Allowing minors and unlicensed/improperly licensed person to drive	200.00
6. Fake license	500.00
7. Allowing another person to use his license	150.00
8. Certificate of Registration and Official Receipt not carried	100.00
9. Colorum operation (operator) for permitting, allowing, consenting	200.00
10. Colorum operation (driver) – for using a private vehicles for hire	200.00
11. Refusal to convey passengers to proper destination/trip cutting	250.00
12. Reckless driving	100.00
13. Plates not firmly attached and visible	50.00
14. No headlight or defective headlight	100.00
15. No muffler or cut muffler (causing excessive noise)	100.00
16. No rear view mirror	50.00
17. No side mirrors on both sides	50.00
18. No left side passenger	100.00
19. Overspeeding (within Poblacion limit only)	100.00
20. Overloading	100.00
21. Hitching	50.00
22. Allowing passengers on top of cover of vehicle	50.00
23. Unauthorized bell, siren, or exhaust whistle	100.00
24. Disregarding traffic signs	100.00
25. Parking in areas where official sign of prohibition erected	100.00
26. Obstruction	100.00
27. Driving against the flow of traffic	100.00

Section 4. TRAFFIC CITATION TICKETS. (a) Any person apprehended for violating any provision(s) of this Ordinance shall be issued a Traffic Citation Ticket in the form prescribed for the purpose and to be issued by the apprehending officer of the Philippine National Police and/or any duly authorized personnel.

(a) *In the absence of the offending owner, operator, or driver, the Traffic Citation Ticket shall be placed conspicuously on the vehicle*

(b) *The provisions of the Traffic Citation Ticket shall be complied by the offender within the number of days prescribed therein*

Section 5. ENFORCEMENT AGENCY. The Philippine National Police is tasked to enforce the traffic rules and regulations as provided for this ordinance.

Section 6. PAYMENT AND COLLECTION OF FINES. All fines for the violation enumerated as herein shall be paid to the Municipal Treasurer within 7 days from the date of the issuance of citation tickets. Failure to pay the fines specified shall be a ground to cause the impoundment of the vehicle and shall be released only upon payment of the fine imposed and presentation certificate of completion of the seminar conducted by the PNP.

Section 7. APPROPRIATION. The sum of Two Thousand (P2,000.00) Pesos shall initially be allocated from the 20% Economic Development Fund (EDF) for the printing of the Traffic Citation Tickets. Hereafter the costs of the subsequent printings shall be charged to the accumulated collection of fines and penalties for traffic violations.

Section 8. SEPARABILITY CLAUSE. If any provision or part of this Ordinance shall be declared unconstitutional or invalid, the same shall not affect the constitutionality or validity of the other provisions or parts hereof.

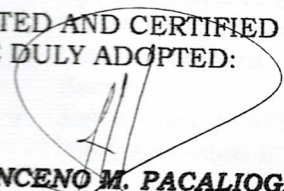
Section 9. REPEALING CLAUSE. If any provision or part of any existing ordinance not consistent with this Ordinance, the same is hereby repealed or modified accordingly.

Section 10. EFFECTIVITY CLAUSE. This Ordinance shall take effect after the approval of the Sangguniang Panlalawigan and fifteen (15) days from the date copy of this ordinance is posted in the Bulletin Board at the entrance of the Municipal Hall and at least two (2) conspicuous places in the poblacion and its publication in newspaper of general circulation in the province.
