Ordinance No. 40, s. 2002

AN ORDINANCE FIXING RATES FOR THE RENTAL OF THE LGU HEAVY
EQUIPMENT OF THE MUNICIPALITY OF DUMINGAG, ZAMBOANGA DEL SUR.

Be it ordained by the Sangguniang Bayan in session assembled that :

SECTION 1. This ordinance shall be called "An Ordinance Fixing Rates of the LGU Heavy Equipment of the Municipality of Dumingag, Zamboanga del Sur".

SECTION 2. There shall be imposed rental for the use of heavy equipments in the following breakdown :

2.1 Rental Rate Per Day

2.2. Any private individual shall be charged for 10 Wheelers Dumptruck - Sand and Gravel. An amount of P500.00 per load shall be charged for the first 5 kilometre plus P50.00 per kilometre for the succeeding kilometre.

2.3. For (10) Wheelers Dumptruck-Loaded with Timber. An amount of P8,000.00 per load shall be charged for the first 5 kilometre plus P50.00 per kilometre for the succeeding kilometre.

2.4. For (6) Wheelers Dumptruck - Sand and Gravel. An amount of P300.00 per load shall be charged for the first 5 kilometre plus P50.00 per kilometre for the succeeding kilometre.

2.5. For (6) Wheelers DT - Loaded with Timber. An amount of P500.00 per load shall be charged for the first 5 kilometre plus P50.00 per kilometre for the succeeding kilometre.

SECTION 3. IMPLEMENTING RULES AND REGULATIONS. The Municipal Mayor through the recommendation of the Municipal Treasurer shall formulate an implementing guidelines for proper implementation of this ordinance.

SECTION 4. SEPARABILITY CLAUSE. If, for any reason, a portion of this ordinance is declared null and void, the rest of the portions thereof not affected by such declaration shall be in effect and subsisting.

SECTION 5. EFFECTIVITY CLAUSE. This ordinance shall take effect after the approval of the Sangguniang Panlalawigan and after fifteen (15) days from the date copy hereof is posted in the Bulletin Board at the entrance of the Municipal hall and in at least two (2) other conspicuous places in the Poblacion, announcement in the Local Cable TV and FM stations and further published in a local newspaper of general circulation once a week for three (3) consecutive weeks, informing the constituents of the provisions and date of the effectivity thereof and subsequent announcement of Local FM station.

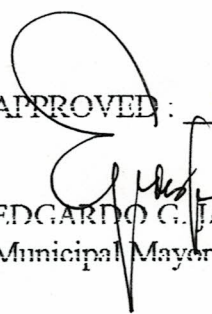
