Ordinance No. 41, s. 2002

AN ORDINANCE FIXING THE RATE OF BUSINESS TAX FOR PUBLIC UTILITY
BUS OPERATING IN DUMINGAG, ZAMBOANGA DEL SUR.

Be it ordained by the Sangguniang Bayan of Dumingag, Zamboanga del Sur in session assembled that :

SECTION 1. TITLE . This ordinance shall be called "An Ordinance Fixing the Rate of Fees of Business Tax to be Imposed to Operators or Owners of Public Utility Bus Operating in Dumingag, Zamboanga del Sur.

SECTION 2. TAX ON BUSINESS. There shall be imposed a Business Tax on Operators or Owners of Public Utility Bus Operating in Dumingag, in the following categories :

- 2.1. First six (6) units of Busses is in the amount of P8,000.00 per year.
- 2.2. 7-8 units of Busses is P10,000.00 per year.
- 2.3. 9-above units P12,000.00 per year.

SECTION 3. IMPLEMENTING RULES AND GUIDELINES. The Municipal Mayor through the recommendation of the Municipal Treasurer shall formulate implementing guidelines for proper implementation of this ordinance.

SECTION 4. SEPARABILITY CLAUSE. Any Section or provision of this ordinance which may be declared unlawful or invalid the remainder of such declarations shall remain to be in full force and effect.

SECTION 5. EFFECTIVITY CLAUSE. This ordinance shall take effect after the approval of the Sangguniang Panlalawigan and after fifteen (15) days from the date copy hereof is posted in the Bulletin Board at the entrance of the Municipal hall and in at least

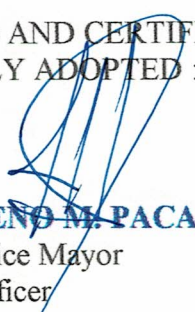
two (2) conspicuous places in the Poblacion, announcement in the Local Cable TV and FM stations and further published in a local newspaper of general circulation once a week for three (3) consecutive weeks, informing the constituents of the provisions and date of the effectivity thereof.

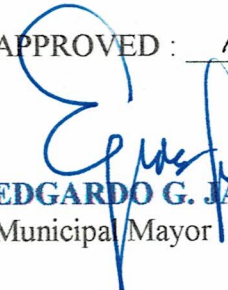
