Ordinance No. 5, 1999

E X P L A N A T O R Y N O T E

WHEREAS, the People's Law Enforcement Board (PLEB) was created under Republic Act No. 6975, as a local community mechanism, principally tasked to investigate and decide citizen's complaints initiated against erring members of the Philippine National Police (PNP) ; and

WHEREAS, pursuant to such Act, the LGU of Dumingag, Zamboanga del Sur had organized the PLEB and appropriated the same incorporating in the annual budget due to its significance, therefore, issuance of PLEB Certification through its Chairman to any requesting member of the PNP for any legal purpose that may serve the best, shall not be taken for granted but be given value.

NOW, THEREFORE, this proposal is indispensable for its enactment.

AN ORDINANCE PRESCRIBING FEE FOR CERTIFICATION
THAT MAY BE ISSUED BY THE PEOPLE'S LAW ENFORCE-
MENT BOARD (PLEB) THROUGH ITS CHAIRMAN, THIS
MUNICIPALITY TO ANY REQUESTING MEMBER OF THE PNP
FOR ANY LEGAL PURPOSE.

Be it enacted by the Sangguniang Bayan of Dumingag, Zamboanga del Sur in session assembled :

Section 1. TITLE - This Ordinance shall be known and cited as
" DUMINGAG PLEB CERTIFICATION LAW OF 1999. "

Section 2. REGULATORY PROVISIONS - (a) There shall be a prescribed fee of TEN PESOS (P10.00) for every Certification that may be issued by the People's Law Enforcement Board (PLEB) through its Chairman, for any legal purpose that may serve the best, to any requesting member of the Philippine National Police PNP.

(b) Any Certification from the People's Law Enforcement Board (PLEB) shall not be issued by its Chairman to any requesting member of the PNP unless payment for such fee mentioned in section 2 hereof has been made to the office of the municipal treasurer and upon presentation of official receipt (OR) therefor.

Section 3. PENAL PROVISION - Any person found guilty of violating this Ordinance may be meted administrative disciplinary action.

Section 4. SEPARABILITY CLAUSE - If, for any reason or reasons, any part or provision of this Ordinance may be held to be unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.

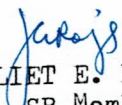
Section 5. EFFECTIVITY CLAUSE - This Ordinance shall take effect after the review by the Sangguniang Panlalawigan.

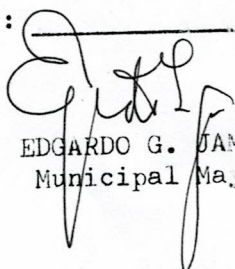
