Ordinance No. 6, s. 2000

**"AN ORDINANCE CREATING MUNICIPAL TASK FORCE ON WOMEN AND
CHILDREN AND PROVIDING FUNDS THEREFOR."**

Be it ordained by the Sangguniang Bayan of Dumingag, Zamboanga del Sur, in session assembled that:

Section 1. TITLE - This ordinance shall be called " An ordinance creating Municipal Task Force on Women and Children and providing funds therefor."

Section 2. CREATION -

- There is hereby created Municipal Task Force on Women and Children (MTFWC) which is composed of eight (8) officers and eight (8) Committee Chairpersons as members comprising of NGO leaders/representatives and government heads of offices or its duly representatives from offices namely DSWD, POPCOM, LCR, DOLE, DOH, MTO, MBO and PNP. The Chairperson of the Committee on Women and Family of the Sangguniang Bayan shall be an ex-officio member of the MTFWC.
- The Officers of the MTFWC shall be the Chairperson, Vice Chairperson, Secretary, Treasurer, Auditor and three (3) PIOs. The ex-officio member mentioned in par. (a) of Section 2 hereof shall takeover the Chairmanship or representation whenever necessary, in the absence of the Chairperson and Vice Chairperson.
- The different committees of the MTFWC shall be the Special Legal Assistance, Law Enforcement, Advocacy Committee, Health Committee, Social Services, Ways and Means and other related committees as maybe provided/created by the MTFWC.

Section 3. OBJECTIVES - The Municipal Task Force on Women and Children aims to:

- Protect and provide temporary critical care for women and children who are victims of abuses.
- Promote the welfare and protection of women and children.
- Monitor all cases involving abuses against women and children.
- Provide psychological care and assistance to the victims such as but not limited to rape, battered wife, sexual harassment, child abuse and other forms of violation against women and children.
- Undertake integrated and preventive activities, intervention towards the reduction of domestic violence.

Section 4. ORGANIZATION, ELECTION AND TERM OF OFFICE.

- a. The organization/re-organization of the MTFWC shall be on the month of July of the first year of the term of office of the elective municipal officials and the election of officers therefor shall be on every month of July, to be initiated/conducted by the Municipal Mayor.
- b. The term of office of the NGO representation to the MTFWC shall be co-terminous with the term of office of the present elective municipal officials. The term of office of the officers shall be one (1) year, which shall expire after the successor, shall have been elected and qualified.

Section 5. ENFORCEMENT OFFICE - The office of the Local Chief Executive shall properly enforce this ordinance for the benefit of Women and Children of the municipality.

Section 6. APPROPRIATION - There is hereby appropriated an amount of one hundred thousand pesos (P100,000) chargeable to the Sectoral Advocacy of the 20% EDF for CY 2000. The amount herein mentioned shall be incorporated in the annual budget for CY 2001 and thereafter, particularly at the twenty percent (20%) EDF, to be prepared by the Municipal Planning and Development Coordinator, for the strengthening and support of programs, projects and activities of the MTFWC.

Section 7. SEPARABILITY CLAUSE - Any section or provisions of this ordinance which maybe declared unlawful shall not affect the other sections or provisions hereof.

Section 8. EFFECTIVITY CLAUSE - This ordinance shall take effect after the review by the Sangguniang Panlalawigan.

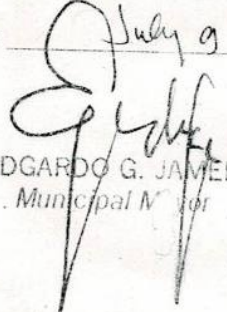
