Ordinance No. 7, s. 2002

AN ORDINANCE MANDATING THE NGOS, POs AND THE DUMINGAGNONS TO UPHOLD AND ADVOCATE
CHILD FRIENDLY COMMUNITY IN DUMINGAG, ZAMBOANGA DEL SUR

WHEREAS, it is at all times the battlecry of the LGU of Dumingag to be child friendly;

WHEREAS, Dumingag is cited and awarded in the campaign to be child friendly community;

WHEREAS, it is still a fact that the whole community is not fully informed of the campaign;
and

WHEREAS, the time has now come to mandate the NGOs, POs and the Dumingagnons to
uphold and advocate a Child Friendly Community;

NOW, THEREFORE, be it ordained by the Sangguniang Bayan of Dumingag in session
assembled that;

Section 1. TITLE. This ordinance shall be "AN ORDINANCE MANDATING THE NGOs, POs AND
THE DUMINGAGNON TO UPHOLD AND ADVOCATE CHILD FRIENDLY COMMUNITY IN DUMINGAG,
ZAMBOANGA DEL SUR."

Section 2. SCOPE OF APPLICATION. This shall apply/cover to the whole community of
Dumingag, Zamboanga del Sur

Section 3. PURPOSE. This ordinance mandates the community to uphold and advocate a child
friendly municipality.

Section 4. MANDATORY PROVISIONS. This ordinance mandates as follows:

1. The existing NGOs, POs shall include and contribute, participate and perform programs
related to the campaign of having a Child Friendly Community.
2. The Dumingagnons are encouraged to actively promote and consider achieving a child
friendly community.

3. Enhance contemplation of the whole community on a specific or collective purpose to achieve a child friendly community.¹
4. Support the LGU in all aspects that objectively support the community to be child friendly

Section 5. IMPLEMENTING GUIDELINES. The office of the Municipal Mayor will formulate implementing guidelines to ensure the effective implementation of this ordinance. It will coordinate with different agencies, offices, NGOs and POs and other individual with similar concern to conceptualize the main purpose of this ordinance and to realize our dream of having a community of child friendly individuals.

Section 6. SEPARABILITY CLAUSE. If any Section or provisions of this ordinance may be declared unlawful or invalid, the remainder shall be in full force and effect.

Section 7. EFFECTIVITY AND PUBLICATION CLAUSE. This ordinance shall take effect after the approval of the Sangguniang Panlalawigan and after fifteen (15) days from the date copy hereof is posted in the bulletin board at the entrance of the municipal hall and in at least two (2) other conspicuous places in the Poblacion, announcement in the Local Cable TV, and FM station and further, published in a local newspaper of general circulation once a week for three consecutive weeks, informing the constituents of the provisions and date of effectivity thereof.

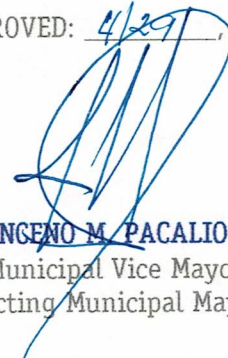
