Ordinance No. 7, s. 2004

AN ORDINANCE ADVOCATING AND STRENGTHENING THE ORGANIZATION OF SENIOR CITIZENS IN THE BARANGAYS OF DUMINGAG, ZAMBOANGA DEL SUR AND PROVIDING GUIDELINES IN THE IMPLEMENTATION HEREOF.

WHEREAS, the organization of Senior Citizens is a constitutional mandate to the declared policy and objective that the State shall provide social justice in all phases of national development giving priority to the underprivileged, the sick, the women and the elderly in general;

WHEREAS, consonant to these constitutional principles in relation to the declared policies and objectives of RA 7432 as amended, Senior Citizens are organized:

- To motivate and encourage Senior Citizens to contribute to the nation building;
- To encourage their families and the communities they live with to reaffirm the valued tradition of caring the elderly;
- To establish mechanisms whereby the contribution of Senior Citizens are maximize,

WHEREAS, the Senior Citizens of Dumingag, Zamboanga del Sur is already organized in accordance with the existing rules and regulations of RA 7432 as amended but is not yet fully organized in the barangays;

THEREFORE, be it ordained by the Sangguniang Bayan of Dumingag, Zamboanga del Sur, in Session assembled that:

SECTION 1. TITLE. This Ordinance shall be called, "An Ordinance Advocating and Strengthening the Organization of Senior Citizens in the Barangays of Dumingag, Zamboanga del and Providing Guidelines in the Implementation Hereof".

SECTION 2. PURPOSE. This ordinance aims to strengthen the organization of Senior Citizens in the barangays to maximize their participation for development at the local level and in the entire country in general and providing their benefits and privileges as provided under RA 7432 as amended by RA 9257;

SECTION 3. SCOPE OF IMPLEMENTATION. This Ordinance shall apply to all barangays of Dumingag, Zamboanga del Sur;



SECTION 4. REGULATORY PROVISIONS. There shall be adopted a local regulatory measures as follows:

1. Advocate and strengthen the organization of Senior Citizens in the municipality and the barangays in particular;
2. Automatic membership to the organization of residents 60 years old and above with an annual income of less than P60,000.00 pesos shall be qualified to apply as member;
3. Enhance participation of Senior Citizens to nation building giving emphasis on their individual contribution for development at the local level;
4. Encourage barangay officials to coordinate in the organization of the Senior Citizens, their programs and activities in the barangays;

SECTION 5. IMPLEMENTING GUIDELINES. The Office of the Mayor thru the Office of the Municipal Social Welfare Development, this municipality shall formulate guidelines to ensure the effective implementation of the ordinance.

SECTION 6. REPEALING CLAUSE. Any provision of an existing ordinance, rules and regulations in conflict with or contrary to the provisions of this ordinance is hereby repealed, amended or modified accordingly.

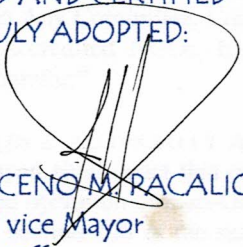
SECTION 7. EFFECTIVITY CLAUSE. This ordinance shall take effect after the approval of the Sangguniang Panlalawigan and after fifteen (15) days from the date copy hereof is posted in the bulletin board at the entrance of the municipal hall and in at least two (2) other conspicuous places in the Poblacion, published in a local newspaper of general circulation once a week for three consecutive weeks, informing the constituents of the provisions and date of effectivity thereof.

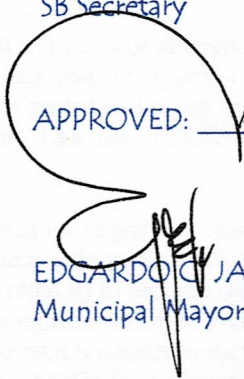
